Coordinator Update

- Rate increases are going into effect July 1st (will be on website)
- Through the rate change 5 new components they separated Residential and Medicaid rate
- Outpatient for IOT for an adult rate and the child rate
- Family Preservation has stayed about the same across the board

Regional Finance Manager

- Budget \$20.4M; YTD Spend \$19.2M/94.08% Target 92.59%
- Prior Year Spend \$18.6M; Spend is up 3% over last year.
 - o Family Preservation Costs up \$938K over last year.
 - o Residential Costs up \$1.6M over last year
- In Home \$5.2M or 27% / Out of Home \$14M or 73% (State Average 17%/83%)
- Total Caseload 818 Caseload down 14% (128) from this time last year.
 - o Decreases: In Home (1), Relative (82), non-Relative (73) and Other (6)
 - o Increases: IA's (34)
