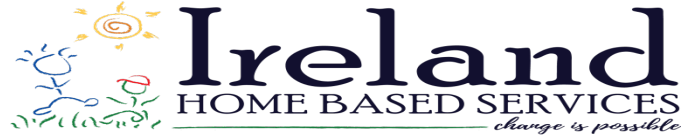
Meeting Minutes

Meeting Called to Order by Brad Fortner, Region 18 Manager

- I. **Welcome, Introduction and Approval of Minutes** Brad Fortner welcomed everyone to the meeting and introduced the council members. Kelly Shellhamer made a motion, seconded by Kayla Bastin, to approve the minutes as read from the July 16, 2021 meeting. All were in favor, motion carried.
- II. **Budget Report** Brad informed those present that our target percentage through September was 27.13% and we are currently at 28.71%. Top expenditures continue to be supervised visitation and children placed in residential settings.
- III. **Programs and Services** Jason Nelson, Regional Services Coordinator, encouraged those present to continue to join bi-weekly calls with David Reid and that there was a call scheduled that day at 1:00 p.m. Those interested in attending the meeting were instructed to e-mail him for an invitation. Currently, Region 18 has 124 active Family Preservation Services referrals and that continues to be a leading number amongst the southern regions in the state. The initial data after a year of offering Family Preservation Services is very positive and showing shorter case times for both Informal Adjustments and In Home CHINS. Jason congratulated Family Preservation providers within Region 18 on the substantial progress being made with families. Jason encouraged everyone to watch the DCS website for information regarding Family Reunification Services. He expects this RFP to be available towards the end of the year or beginning of 2022. Regarding visitation services, Jason informed providers to expect to see more requests for paraprofessional level referrals and to anticipate some service standard changes in the future, including rate changes. He said there is no real difference in the visitation service standard/delivery between bachelor level visits versus paraprofessional level, and that a bachelor level provider can accept a paraprofessional rate visitation referral.
- IV. **Community Partners** Danielle Stansfield, Ireland Home Based Services, presented the community partners report (see attached). Reports included: breakdown of the number of referrals for each county referral source and service type, and a finance report on expenditures. Danielle reported they are running under budget for this time of year. She stated they have a great relationship with schools in Region 18 and that schools are a great source for referrals. They are looking to reach out to additional entities that may have families in and out of their doors to ensure they know how to make service referrals for those families. Since July, they have received 117 referrals - 32 in July, 36 in August, and 49 in September. Currently, they have 54 open and active cases - 19 in Clark, 18 in Floyd, 4 in Harrison, 6 in Scott, and 7 in Washington. Paris Scott shared a community partner's success story with those present.

**Ireland Home Based Services
Community Partner for Child Safety
October 1, 2021**

As of October 1, 2021, a total of 117 referrals had been received since July 1, 2021. A home-based caseworker (HBCW) was assigned to 117 cases, a home-based therapist (HBT) was assigned to 0 cases.

There are 54 levels currently being serviced through Community Partners for Child Safety to assist 54 families.

Region 18 received a total of 32 referrals during the month of July. Of these referrals, 10 cases came from Clark County, 16 from Floyd County, 1 from Harrison County, 3 from Scott County, and 2 from Washington County. Region 18 received a total of 36 referrals during the month of August. Of these referrals, 14 cases came from Clark County, 13 from Floyd County, 2 from Harrison County, 3 from Scott County, and 4 from Washington County.

Region 18 received a total of 49 referrals during the month of September. Of these referrals, 14 cases came from Clark County, 18 from Floyd County, 5 from Harrison County, 6 from Scott County, and 6 from Washington County.

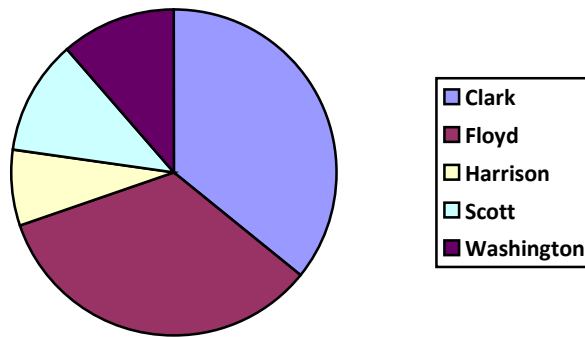

Recent Success Story:

This family referred to Community Partners services for assistance finding housing, employment, transportation and general resources. After meeting with the family, the client shared that her husband recently passed away, he had been the financial provider for the family. IHBS was able to assist mom with finding employment through a home health aid provider. After finding employment they were able to explore housing options and were connected with a private landlord. Within a few weeks the family was able to move into their own apartment that is affordable for mom's new income. IHBS also assisted the family with obtaining social security cards and birth certificates so the family could apply for SNAP benefits. Prior to case closure, IHBS assisted the mom with budgeting her income which allowed mom to see that she could afford a car, this took a lot of stress off of the family. This family was very motivated to accomplish their goals and IHBS was able to close services successfully.

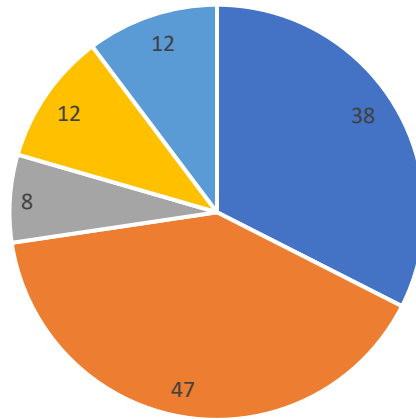

Early Intervention

Substance Use Disorder Program

Program Description

The Early Intervention (EI) program is a separate and distinct program within the Personal Counseling Services' (PCS) Substance Use Disorder Program. This level of care is generally appropriate for clients who are not diagnosed or receive a diagnosis of Mild Substance Use Disorder. Service format, length, and intensity is determined by admission assessment, client preferences and variety of collateral sources of information. Monthly clinical service ranges from one (1) hour to four (4) hours per month. Services can be provided in individual, group or family formats. Clients have access to other services provided by PCS to treat emerging needs. This includes psychiatric medication management, psychological services, trauma therapy and marriage/family counseling.

Program Purpose and Goal

The purpose of PCS' Early Intervention (EI) program is to provide services to those who present with risk for substance misuse, recently engaged in substance misuse, exhibits need for education and intervention services. The program's primary function is to provide early intervention services to minimize the need for a more intensive level of care. The EI program offers services that may vary in intensity and modality.

The program goal is to provide in developing a self-directed drug-free lifestyle that promotes the restoration of family/social relationships, improvement of self-esteem, re-connection with a community, and improving the ability to manage psychiatric and physical concerns.

Admission Criteria

The client must be 18 years old or older.

The client is currently not physically dependent on alcohol or an illicit drug where condition is not currently being managed.

The client has an adequate recovery environment and support systems to promote a recovery-oriented lifestyle.

Biomedical, emotional, and behavioral conditions/complications do not exist or do not interfere with services provided in an outpatient treatment setting.

Assessment results indicating Early Intervention as the appropriate service level of care. Generally this would be a determination of no diagnosis or a mild diagnosis of Substance Use Disorder.

The client has available resources to meet the service attendance expectations of the program.



Outpatient

Substance Use Disorder Program

Program Description

The Outpatient (OP) program is a separate and distinct program within the Personal Counseling Services (PCS) Substance Use Disorder Program. This level of care is generally appropriate for clients who receive a diagnosis of Mild, Moderate or Severe Substance Use Disorder. Service format, length, and intensity is determined by admission assessment, client preferences and variety of collateral sources of information. Clinical service hours range from one (1) hour a month to eight (8) hours per week. Service format includes individual, group or family counseling. Clients have access to other services provided by PCS to treat emerging needs. This includes psychiatric medication management, psychological services, trauma therapy and marriage/family counseling.

Program Purpose and Goal

The purpose of PCS' Outpatient Treatment (OP) has two primary purposes including prevention or minimizing the need for a more intensive level of care or to serve as a step-down support program after a recent successful completion of an Intensive Outpatient (IOP) Program. The OP program (1.0) is a more intensive level of care service than our Early Intervention (.5) Level of Care offering comprehensive, coordinated and defined services that may vary in intensity, length and modality.

The program goal is to assist our clients in developing a self-directed drug-free lifestyle that promotes the restoration of family/social relationships, improvement of self-esteem, re-connection with a community, and improving the ability to manage psychiatric and physical concerns.

Admission Criteria

The client must be 18 years old or older.

The client has a documented history of problematic current/past use of psycho-active substances.

The client is currently not physically dependent on alcohol or an illicit drug where condition is not currently being managed.

The client has an adequate recovery environment and support systems to promote a recovery-oriented lifestyle.

Biomedical, emotional, and behavioral conditions/complications do not exist or do not interfere with services provided in an outpatient treatment setting.

The client has available resources to meet the service attendance expectations of the program.



IOP

Substance Use Disorder Program

Philosophy:

It is the philosophy of Personal Counseling Services (PCS) that addiction is a brain disease having the potential of significantly impairing a person's physical, spiritual, emotional, financial, environmental, occupational, intellectual and social wellness. Program utilizes SAMHSA's 10 Guiding Principles of Recovery and SAMHSA's definition of recovery as a framework for service delivery. According to SAMHSA's publication "SAMHSA's Working Definition of Recovery: 10 Guiding Principles" (2012) defines recovery as "A process of change through which individuals improve their health and wellness, live a self-directed life, and strive to reach their full potential."

The wellness dimensions described by SAMHSA in its publication "Creating a Healthier Life: A Step-by-Step to Wellness" (2016) will be utilized to determine the effectiveness of the services rendered.

Purpose:

The purpose of Personal Counseling Services' Intensive Outpatient Treatment Program (IOP) is to provide treatment for those diagnosed with Moderate to Severe Substance Use Disorder. Our goal is to assist our clients in developing a self-directed drug-free lifestyle that promotes the restoration of family/social relationships, improvement of self-esteem, re-connection with a community, and improving the ability to manage psychiatric and physical concerns.

Program Services:

- Minimum of nine (9) clinical hours a week for twelve (12) weeks.
- Client must attend thirty-six (36) total group sessions and two (2) individual sessions per month to receive a completion certificate.
- It is recommended that the client has at least two (2) sessions with a family member, friend or significant other attending.
- Each client has access to other services provided by PCS to treat emerging needs. This includes psychiatric medication management, psychological services, trauma therapy and marriage/family counseling

Program Description: Personal Counseling Services offers an outpatient Substance Use Disorder Program that provides services in three levels of care for the treatment of substance misuse and addiction. Services range in intensity of care ranging from Early Prevention (.5), Outpatient (1.0) to Intensive Outpatient (2.1).

Service Formats: Individual, Group, and Family Counseling

IOP Program:

- 9-12 direct clinical service hours a week for 12 weeks
- Group Sessions: 3 days a week (3 hours each)
- Individual Sessions: 2 sessions a month

Insurances Accepted:

Optum, Indiana Medicaid, Anthem (Commercial and Medicaid), Aetna, Humana, Tri-Care, MD Wise, Cigna, Beacon, SIHO, MHS (Cenpatico)

*We also have an adjusted fee scale for those un-insured or under-insured.

Admission Procedures:

- 1) Prospective client calls Intake Coordinator (812-283-8383 Ext 121) leaving a message.
- 2) Intake Coordinator will return call and will complete screening to determine eligibility for program.
- 3) If eligible for services, an appointment for an admission assessment will be scheduled.
