# **Meeting Minutes**

Meeting Called to Order by Brad Fortner, Regional Manager.

- I. Welcome, Introduction and Approval of Minutes Brad Fortner, Regional Manager, welcomed everyone to the meeting and introduced the council members. Tawana Jackson made a motion, seconded by Caitlin Busick to approve the minutes as read from the April 2023 meeting. All were in favor, motion carried.
- II. Budget Report Debbie Dailey, Regional Finance Manager, was unable to attend and Brad Fortner shared updates on the FY 23 budget year through June 2023. The region spent 101.48% of our budget. Average caseload for FY 23 was 862 compared to FY 22 of 973, which was a 11% decrease in the average number of children served. With the decrease in number of children being served there was a decrease in community-based services costs, as well as foster care and LCPA costs. Driving costs pushing the region over target are residential costs which increased 22.59% over last budget year. One contributing factor to the increase in residential care is that effective 1/1/23 residential rates for most facilities increased. This increase can be seen in March through June residential expenditures not only in region 18, but across the state. Overall, the average number of children in residential decreased from 45 to 41 when comparing FY 22 to FY 23. The FY 24 budget began 7/1/23. Regional allocations include adjustments for changes in community-based service hourly rates from the Milliman study and the addition of the Kinship stipend.
- III. Programs and Services Jason Nelson, Regional Services Coordinator, reminded everyone that the virtual statewide Family Preservation provider call is this afternoon. Biggest change since the last meeting is that juvenile probation cases can now receive Family Preservation services. Within region 18 there are 90 active referrals and 15 of those are juvenile probation cases. Prior to allowing juvenile probation cases, active referrals hung between 90 and 100. Numbers are heading in the right direction when it comes to additional substantiations after Family Preservation services. Region 18 has been very effective in taking a more direct approach to work with families by intentionally and quickly progressing towards case closure. New rates took effect on July 1st. Jason thanked our partner agencies and field staff, congratulating them on the good work with the new supervised parenting time service standard. The goal was not to change referral types but to meet the family's need and that interventions be as minimal as safety permits. Region 18 is second in the state when it comes to fitting the service to the family. We have been able to utilize standard supervised parenting time referrals at a rate of 85%, which is much higher than other regions in the state.
- IV. Community Partners Danielle Stansfield, Ireland Home Based Services (IHBS) presented the community partners report (note reports forwarded after meeting date). Reports included: breakdown of the number of referrals for each county referral source and service type, and a finance report on expenditures. June 2023 totals were not finalized at the time of the meeting, but Danielle shared that through May 2023 they had utilized 100% of their budget. Fortunately, they were granted additional funding to cover the overage. She is unsure if there will be additional funding granted in the next budget year but will communicate updates with the council once more information is received. There were 641 referrals received in FY 2023: 279 for Clark, 222 Floyd, 31 Harrison, 65 Scott, and 43 for Washington. The year before in FY 2022 they received 573 referrals. Currently have 31 open referrals.

Paris Scott shared a community partner's success story with those present.

There was a Community Partners statewide meeting yesterday where other agencies shared their plans to open family resource centers. One agency will be opening their center next week in August, and a couple of other agencies shared they would be opening in September or October. Region 18's target date is still to open in October or November. In August, the IHBS team is attending a training being held by the DCS Prevention Team that is partnering with Firefly. Firefly already has a resource center that was put in place by the Indiana School of Social Work a couple years ago. Danielle and her team will also

be attending a national training in September regarding the Standards of Quality Certification for the upcoming family resource center. Danielle shared the finalized recent survey results. Most prevalent needs were additional mental health services, parenting support, safe sleep, education, financial support, job readiness programs, substance abuse support and life skills. The results of this survey will be used when building calendars, planning events and scheduling speakers for the upcoming family resource center. Paris Jackson has been searching and reviewing potential locations for the center. They are still working on proposals, and nothing has been finalized yet, but the hope is that the center will be in a location that people can easily walk to and accessible from the Housing Authority in Clark County.


- V. Other Business Service Providers introduced themselves and gave updates on their programs.
