Meeting Minutes

Meeting Called to Order by Brad Fortner, Regional Manager.

- I. Welcome, Introduction and Approval of Minutes Brad Fortner, Regional Manager, welcomed everyone to the meeting and introduced the council members. Tawana Jackson made a motion, seconded by Myra Albertson to approve the minutes as read from the October 2023 meeting. All were in favor, motion carried.
- II. Budget Report Debbie Dailey, Regional Finance Manager, was unable to attend and Brad Fortner shared updates on the FY 24 budget year through September 2023. Region 18 target for expenditures July September was 25% and the region spent 24.21%. The number of children served has been decreasing since January, 882 children vs 791 children in September showing a 10% decrease. Residential numbers have decreased from 43 children to 37 children. When comparing average spend to the previous quarter (April, May, June) to most recent quarter (July, August, September) there has been a 2.16% increase. This is partially due to the service hour rate adjustment that went into effective July 1, 2023, and the recent new kinship stipend. Budgets were adjusted for these expenditures when allocated in June.
- III. Programs and Services Jason Nelson, Regional Services Coordinator, shared that it is time to begin working on the Biennial Regional Services Strategic Plan. The state's goal is to assign uniform service goals for each region. A region workgroup will be created to put together a plan including action items that are specific to each region. To collect and achieve these goals, there will be a public testimony hearing scheduled for November 17, 2023, at 9 a.m. at the Floyd DCS Office. Once we've had the public hearing, we may send out invites to some of our partner agencies and members of the Regional Service Council to participate in the workgroup. Jason shared that the plan this year will revolve around engaging parents a little bit more effectively and improving services that are more individualized and specific to families. Once the Biennial Plan is complete, he anticipates there will be a quorum vote to approve that plan at our first Regional Service Council meeting in 2024. After that it will be submitted for local office director approval.

There is a statewide Family Preservation virtual meeting today at 1:00 p.m. and Jason encourages everyone to attend. There will be a focus in discussion on intervention to maintain safety in the home. The region has about 110 Family Preservation cases and 21 probation cases open, which is the highest we have seen so far. Probation was able to begin making referrals for Family Preservation in January 2023. For probation, we do not mandate that every case gets a Family Preservation referral but are making them when it makes sense for that family and youth.

Jason is hoping to schedule a provider meeting in December for regions 13, 14, and 18 to talk about supervised parenting time and adjustments that have been made to that service standard. He commended providers and staff in region 18 with reimaging what those services look like (standard and enhanced) and the idea that supervised parenting time is limited and we intervene as little as possible. The goal is to make sure referrals are at the standard level whenever safety allows. Region 18 is within the top 5 regions correctly referring this service out.

IV. Community Partners Danielle Stansfield, Ireland Home Based Services (IHBS) presented the community partners report through August 2023. Reports included: breakdown of the number of referrals for each county referral source and service type, and a finance report on expenditures. Through August the target was 17% and they have used 16%. There were 168 referrals received so far in July and August: 64 for Clark, 57 Floyd, 8 Harrison, 26 Scott, and 13 for Washington. Currently have 65 open referrals. Danielle shared they were hoping to open the Family Resource Center in November but there were some delays with renovations. There is not an updated opening date currently. Danielle and her team are looking into mobile outreach for the community throughout November to see if that is a possibility. Once she has more information and dates available, she will share.

Paris Scott shared a community partner's success story with those present.

Ireland Home Based Services Community Partner for Child Safety October 1, 2023

As of October 1, 2023, a total of 168 referrals had been received since July 1, 2023. A home-based caseworker (HBCW) was assigned to 168 cases, a home-based therapist (HBT) was assigned to 0 cases.

There are 65 levels currently being serviced through Community Partners for Child Safety to assist 65 families.

Region 18 received a total of 35 referrals during the month of July. Of these referrals, 11 cases came from Clark County, 14 from Floyd County, 4 from Harrison County, 6 from Scott County, and 0 from Washington County.

Region 18 received a total of 76 referrals during the month of August. Of these referrals, 36 cases came from Clark County, 17 from Floyd County, 2 from Harrison County, 12 from Scott County, and 9 from Washington County.

Region 18 received a total of 57 referrals during the month of September. Of these referrals, 17 cases came from Clark County, 26 from Floyd County, 2 from Harrison County, 8 from Scott County, and 4 from Washington County.



Current Open Referrals




Success Story

We received a referral for a family through their Scott County school in July 2023. The child was facing truancy from missing a lot of school due to transportation issues. Due to health complications the child had to have multiple surgeries and since mom did not have transportation, she was unable to get him to school after his physical therapy. IHBS was able to talk to the school and come up with a plan to successfully get the child to school. The school, mom, and IHBS agreed on the plan of having the child do online school and once he has successfully completed all of his multiple surgeries and been cleared from physical therapy, he will rejoin inperson school. IHBS was able to help mom register her child into an online school program and was able to help them get a free laptop through the online school's registry. Upon completing services in September 2023, the child was logged in to his classes so that he could complete assignments. Mom was relieved that he would no longer miss any more school.
