Meeting Minutes

Meeting Called to Order by Brittany Webster, Floyd Local Office Director

- I. Welcome, Introduction and Approval of Minutes Brad Fortner, Regional Manager, was unable to attend meeting and Brittany Webster, Floyd Local Office Director, filled in as co-chair. Brittany welcomed everyone to the meeting and introduced the council members. Tawana Jackson made a motion, seconded by Mark Barry, to approve the minutes as read from the July 2022, meeting. All were in favor, motion carried.
- II. Budget Report Debbie Dailey, Regional Finance Manager, gave an update on the SFY 23 budget through September 2022. The region spent 24.88% with the target being 26.34%. From September 2021 to September 2022 the number of children served decreased by 16%. Of children served, 36.5% were In Home and/or Informal Adjustments. If you add children placed in a relative home, which is a family like setting, the region is at 62.4%. Of children in Out of Home care, 40.8% are placed in relative care, 41.7% in foster care and 7% are in residential. A year ago in September 2021, the region was serving 59 children and at the end of this September we were serving 39.
- III. Programs and Services Jason Nelson, Regional Services Coordinator, thanked all the family preservation providers that were able to attend the family preservation meeting in August. Jason felt DCS leadership came away with a lot of good topics to discuss, especially regarding creating a sense of urgency in cases where there is significant substance abuse. Jason hopes to have another meeting in the beginning of the year to re-visit topics and review progress. He also shared that Milliman Group will be looking at community-based service rates to evaluate and compare what other states pay for similar services. Providers should have recently received a survey or some form of communication from Milliman Group about rates and cost of providing services. Jason said the region has about 15 providers since the family preservation program launched; 8-9 of those are getting consistent referrals or have availability. FCMs are taking advantage of DCS Services Hub, and Jason advised providers to make sure to keep their availability updated in that system.
- IV. Community Partners Danielle Stansfield, Ireland Home Based Services (IHBS), presented the community partners report (see attached). Reports included: breakdown of the number of referrals for each county referral source and service type, and a finance report on expenditures. Danielle shared they only have the finalized budget numbers for July and August. Their target through August was 17% and they utilized 21% of the budget. She has seen a slight increase in referrals and will continue to monitor that. If referrals continue to increase, she may have a different conversation regarding getting families connected to resources and services sooner and closing out. For now, there will not be changes in how services are provided. Danielle ended by sharing that 172 referrals were received in July, August, and September: 73 for Clark, 62 Floyd, 9 Harrison, 15 Scott, and 13 for Washington.

Paris Scott shared a community partner's success story with those present.

Ireland Home Based Services Community Partner for Child Safety October 1, 2022

As of October 1, 2022, a total of 172 referrals had been received since July 1, 2022. A home-based caseworker (HBCW) was assigned to 172 cases, a home-based therapist (HBT) was assigned to 0 cases.

There are 67 levels currently being serviced through Community Partners for Child Safety to assist 67 families.

Region 18 received a total of 55 referrals during the month of July. Of these referrals, 25 cases came from Clark County, 19 from Floyd County, 5 from Harrison County, 4 from Scott County, and 2 from Washington County.

Region 18 received a total of 54 referrals during the month of August. Of these referrals, 19 cases came from Clark County, 23 from Floyd County, 1 from Harrison County, 5 from Scott County, and 6 from Washington County.

Region 18 received a total of 63 referrals during the month of September. Of these referrals, 29 cases came from Clark County, 20 from Floyd County, 3 from Harrison County, 6 from Scott County, and 5 from Washington County.



Current Open Referrals




Success Story

This family was referred to Community Partners by DCS. The family consisted of a single mother and two children. The family was homeless and needing stable housing. Upon meeting with the family, it was discovered that the teenage daughter in the home was also pregnant. We worked with mom on a budget and connecting her to community resources in her area, and also connected her with WIC, Choices, and Nurse-Family Partnership for the pregnant teen. At the end of September, mom obtained the keys to her new apartment due to our help in connecting her with the Trustees and a local church, both of which were able to assist in paying her deposit and first month's rent. Community Partners funding was utilized to purchase bedding and additional household items. Services were closed with this family as they felt they were able to successfully complete their goal and navigate Community Resources on their own.
