I. Welcome/Roll Call: Introductions

II. Approval of Minutes: Teresa Patrick made a motion to approve the October 16, 2024, minutes; K-Lynn Minor seconded; all in favor.

III. PROGRAMS/COMMITTEE REPORTS:

- A. Community Partners / Chrystal Hardin
 - 1. Quarterly Report, Referral Report, Budget & Flex fund reports emailed to council members.
 - Quarterly Report: As of 1/1/2025 117 referrals had been received since 10-1-2024: Breakdown: Oct: 43; Nov: 44; Dec: 30.
 - o HBCW was assigned to all 117 cases.
 - o 18 current open referrals
 - Success Story: Recently widowed mother and 3 children were referred by DCS to help family gain financial stability after the loss of their main supporter. IHBS assisted with back rent. They also linked family to community resources to assist with Christmas and ongoing needs.
 - Referral Report: Region and county breakdown of referrals received since 7-1-24 including referral sources.
 - o Dearborn: 54; Decatur 43; Jefferson: 42; Ohio: 6; Ripley: 31; Switzerland: 16; for a total of 192
 - Budget: As of End of November target is 42%; actual 37.5%
 - Flex Funds: utilized for utilities and housing so far during fiscal year

B. Regional Finance Manager - Belinda Foreman

- 1. Region 15 continues to run over budget like most of the state; target is 50%; actual is 60.23%.
- 2. Providers: reminder to attach reports utilizing naming convention
- 3. Payment turnaround is an average of 43 days.

C. Regional Services Report – Jon MacMurdo

- 1. Currently working on RFPs for community based services. No timeline regarding approvals yet.
- D. Biennial Plan Goal: Provider Presentations:
 - 1. LaTresa Hart & Beth Hazen / Choices Currently in process of hiring/training staff; will take minimum of 30 days before they will be able to take referrals.
 - MST (Multi Systemic Therapy)
 - o Kids may or may not be part of the Juvenile system
 - Practitioners are assigned small caseloads w/intensive services;
 Partnering with MST Institute to ensure high fidelity model being upheld

- \circ Service is for 12 17 yo kids with an identified caregiver as the program requires heavy parental involvement along with kids
- Referrals are staffed with Service Consultant to ensure child/family is appropriate for services
- Youth in ESC or residential and identified as going home soon is an appropriate referral
- o 3-6 month program
- Question: Who is NOT appropriate: Sexually Maladaptive, lower functioning/low IQ (need to be able to comprehend program); active delusional/homicidal/suicidal thoughts; may have some wiggle room with age depending on maturity level



- IFCS (Intensive Foster Care Services)
 - If you have kids placed in Marion or "donut" counties, Lake or Porter they can currently provide services in these counties; not quite ready in Region 15
 - Program designed to meet the needs of any age youth and support caregivers
 - o First focus is on stabilization
 - Crisis & safety planning available to FP 24/7
 - Trust based Relational Intervention (TBRI)
 - o Crisis Peer responders; can provide extra support to the team
