#### Provider Update

- Centerstone
  - State Medicaid CCBHC demonstration Centerstone was approved to do
- Bowen Center
  - Has hired a second Case Manager
  - Will be building a new facility in Decatur in October
- Family Center Services
  - Working on connecting with Blackford, Grant and Jay
  - DCS has recognized that services can continue for families even after their case has been closed with DCS, with grant funding given to FCS.
- ASI Community Wellness Group
  - Have a total of seven offices
  - Offers:
    - Parent Education
    - Parent Aid stated May 1<sup>st</sup>
    - Working on getting certified to do DV
- Family Links Indiana
  - Located in Grant County
  - Hired 2 new staff members who are open for new cases

- Resource Treatment Center
  - Have 4 Group Homes whose been in residential and completed and are ready to step down but don't quit have some place to go
  - Windrose is a female group home focusing on psychiatric treatment and independent living skills for adolescent females ages 14-20. The adolescent girls can complete their education, obtain employment in a structured and supervised family-like setting.
  - Cardinal Point group home is dedicated to adolescents, ages 14-20 who identify as LGBTQ+ and are addressing mental health issues. This group home is a safe, structured setting where the adolescents receive psychiatric treatment and independent living skills.
  - Polaris and Carina group homes are located off site in Indianapolis. Polaris and Carina serve males who have completed a treatment program for sexually harmful behaviors and who need a safe setting with staff who can assist them in following their safety plan while learning healthy behavioral, educational and employment skills. Carina is dedicated to younger males and Polaris works with older males. Males in these homes range from ages 11-20. Each group home offers resident's individual rooms.

## Regional Finance Manager-Financial Status Reports – May 2024

- Budget - \$24.6M; YTD Spend - \$23.5M/95.67% Target 91.67%
- Prior Year Spend - \$19.2M; Spend is up 22% over last year
  - Family Preservation Costs up \$705K over last year
  - Residential Costs up \$1.9M over last year
- In Home \$5.9M or 25% / Out of Home \$17.6M or 75% (State Average 15%/85%)
- Total Caseload 894. Caseload up 3% (29) from this time last year.
  - Decreases: Non-Relative (19)
  - Increases: In Home (36), and Residential (3)
