## **Lifeline Service Addition:**

Lifeline is interested in adding Homemaker/Parent Aid in Region 12. They currently have staff available to begin providing this service right away. This service would be available for probation as well.

Budget allotment \$9,396,635.61- expenditures year to date- \$2,769,075.20, an 11% increase from prior year to date. DCS is over the targeted expenditure of 25% by almost 5% at 29%.

Probation – expenditures year to date- \$799,509.23 down 1.14% from prior year to date. No specific allocation has been received for Probation to date.
