Budget Update

Referral extensions were done July 5, 2017 and all providers should be receiving their list of what referrals were extended.

Substance abuse standard is changing. DMHA is updating their access site policies for CMHI which will bring new policies for wraparound services. DCS will be updating their policies once DMHA releases their updates.

We are still in need of two foster parents and a CASA member for our RSC membership.

New Business

The Biennial Regionals Services Strategic planning in underway. All regions will not create new plans this go around, but will be updating the existing plan. Workgroups will be assembled on each of the 4 categories. The Four Categories are Prevention Services; Maltreatment after involvement; Permanency for Children in Care 24+ months; Substance Use Disorder Treatment. The Biennial Plan will be a living document that will be revised and updated as needed.

Vigo County National Night Out is September 12, 2017 Susie's Place will have an open house on August 3rd from 4:00 P.M, to 7:00 P.M. FSA reported they have a free trauma group for children ages 11-16 and another group for ages 5-10. This is a grant through the Community Foundation and they are looking to fund a third group.
