Susan Baker handed out Service Standard report, Material Relief report, and Financial Report for Community Partners; stating agencies are on target for spend down.

#### 7. Preservation Services:

RFP - Region 14 has a need for additional HB Providers.

Upon approval of the council 41 Services and 12 Providers will be added for Region 14; See Service Guide below.



#### **Approval of Additional Services and Providers:**

Judge Bruce MacTavish motioned to approve, Judge Heather Mollo seconded, members and proxy approved.

Judges (Barth, Jackson, and Johnson) are interested in developing Drug Court for Region 14, stating this could help change the counties.

Seeing positive results through the START program – interest in Region 14, would like more information.

#### 8. Regional Financial Status Report:

Region 14 Budget allocation is 12.6M. Expenditures are 11.4M year to date. 90.9% of Budget Spent / Target 58%, overall increase from last year 16%

#### 9. Public Comment & Adjourn:

Children's Bureau hired a Case Manager for Jackson and Jennings Counties; start date 3/28/16. They have also become a Safe Sleep Distribution Center for Johnson Co.

Ireland HB Services is a Safe Sleep Distributor for Region 14 – they have cribs available at any of their offices. Video for Purple Crying is included with cribs.

April is Child Abuse Prevention Month –Region 14 will have events in each county: Bartholomew-Pinwheel Planting and Celebration of Prevention Services 4/1/16 Jackson-Celebration of Prevention Services on 4/14 or 4/21/16 Jennings-Annual Candlelight Vigil at the Courthouse 4/27/16 and other contests Johnson-Pinwheel Garden and Celebration of Prevention Services at the Courthouse on 4/15/16 Shelby- Having Blue Week, working with children in the elementary schools.
