1. Welcome:


Desirae Moore welcomed members and audience.

4. Community Partners for Child Safety Report (CPCS) Prevention Services:

Susan Baker handed out Service Standard report, Material Relief report, and Financial Report for Community Partners; stating agencies are on track for spend down. Discussed upcoming Provider Fair.

### **5. Prevention Services:**

Presentation by Kristen Schuetz and Mary Jane Shireman with CEHS Mentoring Program. Mentors go through a 6 week training focused on leadership, relationships, mentoring others, problem solving, self-esteem, and confidence; students apply to join the program. There are 25-30 peer mentors in the program, each having 2 mentees; they have had very positive results from this program. Funding allows them to plan activities, have food, and continue to grow; at approximately 90 people to date.

#### **6. Preservation Services:**

RFP - Region 14 has a need for additional HB Providers.

In the process of getting latest requests of proposals, RFP will close in June; will have results to present at next RSC meeting.

Since January 2016, Region 14 has made 478 case referrals, 201 HB Therapy referrals, and 200+ referrals for substance abuse treatment.

### 7. Regional Financial Status Report:

Region 14 Budget allocation is 12.6M. Expenditures are 14.3M through April.
