BACKGROUND

Federal regulations require the Title IV-D agency to initiate actions for paternity establishment in all Title IV-D cases in which a child was born outside of marriage and paternity has not already been established. Paternity may be established administratively by executing a paternity affidavit or by judicial action.²

POLICY

Within 75 calendar days of the Title IV-D Prosecutor's Office determining that it is necessary to locate the alleged father or non-custodial parent (NCP), the Title IV-D Prosecutor's Office must access all appropriate locate sources.³ Repeat locate attempts must be made either quarterly or upon receipt of new information.⁴

Within 90 calendar days of locating the alleged father or NCP, a child support order must be established or service of process completed in order to commence proceedings to establish a child support order and, if necessary, establish paternity.⁵

Unsuccessful attempts to serve an alleged father shall be documented in the case file and the statewide child support system.⁶

The Title IV-D Prosecutor's Office may refer the case to the State Parent Locator Service (SPLS) in order to locate an alleged father or NCP in order to obtain good service for a court hearing to establish paternity.⁷
