## **Meeting Minutes**

**Meeting Called to Order at**: Regional Service Council meeting was called to order by Terrance Ciboch, Regional Manager for Region #2, at 5:30 P.M. CST.

- 1. Roll was called, and the Regional Service Council introduced. It was noted that a quorum was present and seated.
- 2. July 1, 2015 minutes: Magistrate Jonathan Forker made a motion to accept the July 1<sup>st</sup> minutes as written and was seconded by Jack McGlone. Vote taken, 0 opposed, 0 abstentions, minutes passed.
- 3. Unfinished Business: None
- 4. New Business:
  - A. Region 2 Services Update:

Dion Smith discussed the recent RFP for Day Treatment primarily for juvenile probation. There were 6 proposals which were viewed and scored

by local directors. Out of a possible score of 25 the following providers scored:

After a discussion, Jack McGlone made a motion to accept the proposals from LaPorte County Board Of Commissioners and New Beginnings Life Center with Dee Lynch seconding the motion. Vote taken, 0 opposed, 0 abstention, motion passed.

- C. Biennial Strategic Services Plan & Child Protection Plan: Mr. Ciboch went over the plan's highlights concentrating on the information pertaining to Region 2.
  - 1. Co-parenting / Parent Mediator
  - 2. Enhance FCM's understanding and knowledge of Service Standards and utilization
  - 3. Permanency for children in care 24+ months
  - 4. Increase substance use prevention programs
  - 5. Create a Service Standard for Transportation

After a discussion of the different issues and the child protection plan, Sharon Mathew made a motion to approve the Biennial Strategic Service and Child Protection Plan for Region 2 and Claudia Clark second the motion. Vote taken, 0 opposed, 0 abstention, motion passed.

6. Testimony / Announcements Public:

Lisa Sharp wanted clarification of the money split for Body Safety and Stewards of Children which is a mixed position. Mr. Ciboch discussed how high drug involvement is how money is needed but in the new fiscal year the money will be discussed and possible reallocated for drug abuse. Judge Shurn questioned on Pulaski School's interest in Body Safety.

Jim Burns questioned if they could ask the state for more prevention money in which Mr. Ciboch stated they can always ask but was unsure if there was extra money available due to the time frame.

Melanie Dooley handed out new updated Tot Shop brochures.

7. A motion to adjourn was made by Jack McGlone and seconded by Dee Lynch, motion passed without opposition, meeting adjourned at 6:43 p.m. CST.
