1. **Call to Order** – Meeting was called to order at 9:02am.

2. Roll Call

All members present, quorum was met.

3. Review Code Change Proposals

Committee suggested asking the Attorney General to determine which terms are already included in statute. Mr. Dyer informed the Committee that the Committee is ultimately responsible for determining conflicts between code and statute, and that legal can only be of limited assistance as DHS legal is not subject matter experts but will provide assistance as it is able. Mr. Burgauer clarified that DHS legal will help as directed but relies on the Committee as subject matter experts to identify which parts need legal review. Discussion commenced about the scope of work the Committee is expected to do and delineation of work.

- a. **196 – Definitions – Townhouse** – Proposal to change the definition to use Indiana’s statutory definition, which is slightly more robust. Committee unanimously **approved**.
- b. **197 – Definitions – Townhouse Unit** – Already defined in statute as part of Class 2 structure. Committee unanimously **approved**.
