1. Call to Order

Meeting was called to order at 9:08am.

2. Roll Call

A roll call was taken to determine member participation. A quorum was met. See above for details regarding attendees and means of participation.

3. Review of June Minutes

Change reference in proposal 383 to ASCE 7-22. Committee approved minutes.

4. Review of Code Change Proposals and Fiscal Impact

 342 – 304.1 – Business Group B – Mr. Cross submitted two alternate code change proposals. Tabled.

- ii. **353 918 Emergency Responder Communication Coverage Tabled** without discussion while we wait on Mr. Frost and Mr. Patarino. Some discussion was had on getting radio coverage experts in to discuss potential workable alternatives.
- iii. 373 909.18.8 Testing for Smoke Control Chapter 17 defines scope of testing. If proposal adopted, Chapter 17 may not have an effect under current statutory language. Substantial discussion was had on testing methods and standards absent specific statutory requirements, as well as current methods and practices of testing and procedure. Withdrawn.
- iv. 374 909.19 System Acceptance Test Withdrawn.
- v. 375 909.20.6.3 Acceptance and Testing Withdrawn.
- vi. 376 909.3 Special Inspection and Test Requirements Withdrawn.
- vii. **392 1809.5 Frost Protection –** Carryover amendment changing snow map to snow chart. **Approved.**

5. Other Committee Business

Mr. Cook and Mr. Hawkins asked about the status of Mr. Hunter Cullen's proposals. Director Dyer informed the Committee that discussions with Mr. Cullen were ongoing, but the proposals were not in a place that could meet the minimum requirements to bring a proposal before the Committee, but that staff continues to work with him to get the proposals into the right format.

Mr. Hawkins noted that there is no fiscal impact from Chapters 16 to 25.
