- v. **Vote for Plumbing Code Update** – Kaitlin O’Neil presented for DHS. Need to amend to maintain federal compliance. Reduces lead quantity for lead-free from 8% in water pipes and fittings to not allow drinking water pipes to have more than .25% lead. IDEM will lose potential funding if Indiana doesn’t come into compliance, more than \$2M. Mr. Popich asked about language, Mr. Burgauer explained that the 2015 and later ICC language was used but had to be molded to the 2006 current code. Noted a typo in proposed rule change. Definition 25, “Townhouse,” conflicts with statute. Defined in IC 22-12-1-5. Mr. Burgauer notes that changing a definition in rule does not meet the emergency requirement, especially when statute already overrides it.
