EMS State Director Kraig Kinney stated that the Trauma Care Committee has been looking at the ACS pre-review process. There should be a report in early January.

- a. Governor's Public Health Commission (GPHC) update (attachment #1) Director Kinney and Executive Director Thacker talked about the Public Health report and the impact is could have on EMS in Indiana. Director Kinney gave an overview of the report and the role that IDHS had with the Commission.
- b. Scope of Practice OTC and internasal Glucagon (attachment #2) Director Kinney gave a background of why this was needed. Dr. Yazel weighed in on the medical side of the issue. Per the written proposal, staff requested to add OTC medications and intranasal glucagon to the EMT and advanced EMT scope of practice.

Director Kinney introduced Hilary Egan to update the EMS Commission about the readoption of the 836 IAC rules.

STAFF REPORTS

- a. Data Registry Ken Foster reminded everyone that reports are due 24 hours after the run is completed. We are about 90% compliant with EMS reporting and about 69% compliant with NIFERS reporting.
- b. Operations Report Jason Smith gave the operations report. Director Kinney thanked Don Watson for staying in the office during the conference.
- c. Compliance Report Candice Pope reminded everyone to use the new web forms. Reminded everyone about the portal expiration certification. Again, staff reminded everyone of the need to get Medical directors and TI officials PSID numbers for the work flows.
- d. Certifications Report
 - i. Providers (see attachment #4) report submitted for information only. No action taken. None required.

<u>STATE EMS DIRECTORS REPORT</u> – Director Kinney reminded all the Commission members to complete their ethics training. Director Kinney also talked about the office remodel, staffing, the MIH Coordinator opening, the 836 readoption, the state EMS officials retreat, mentioned the EMS Compact and that he has been voted on as a member of the NREMT Board of Directors. All 5 provider district forums were successfully completed. Director Kinney thanked the IEMSA for hosting the meeting and thanked all EMS providers for their service.

STATE EMS MEDICAL DIRECTORS REPORT - Dr. Eric Yazel recognized staff for their hard work. Talked about the public health report, Behavior health has recognized EMS. EBOLA there are 80 -90 patients being monitored for EBOLA in Indiana. He has made it to visit 33 counties now. He briefly discussed the state Inservice opportunities.

<u>CHAIRMAN'S REPORT AND DIRECTION</u>- Chairman Turpen announced the EAGLES conference coming up in January. By Chairman's direction on the AEMT cardiac monitoring issue - Chairman Turpen assigned Commissioner Zartman to look at curricula, ECG monitoring and recognition and the time it would take to properly train AEMTs to conduct cardiac monitoring. Assigned staff to look at the effect on the EMS Compact if the change to the AEMT level is made and the fiscal impact it would have. Chairman Turpen will look at if it would be for transfer only or 911 response.
