CORE CAPABILITY	0 points – Non-allowable Core Capability
	1 point – Low Priority
	3 points – Medium Priority
	5 points – High Priority
HOW DOES PROJECT CONNECT TO CORE CAPABILITY/GAPS IDENTIFIED?	0 points – Project not connected to the core capability chosen.
IDENTIFIED?	1 point – Project provided very minimal connection to Core Capability.
	3 points – Project provided adequate connection to Core capability.
	5 points – Project provided multiple detailed and specific connections to the chosen Core capability.

ARE THE ITEMS ALLOWABLE?	0 points – Non-allowable items.
	3 points – Some items are allowable, some not.
	5 points – All items are allowable.

HOW WELL DOES THE APPLICANT TIE THEIR PROJECT TO TERRORISM?	0 points – Does not mention terrorism.
	1 point – Rarely mentions terrorism and
	there is no clear tie to the project.
	2 points – Rare mention of terrorism with
	a weak tie to project.
	3 points – Adequate mention of terrorism
	and adequate tie to project.
	4 points – Good amount of mentions of
	terrorism and good tie to the project.
	5 points – Provided multiple detailed and
	specific mentions of terrorism that directly tie into the project.

HOW WELL DOES THE PROJECT INCLUDE COLLABORATION WITH MENTIONED ENTITIES?	0 points – Applicant does not mention any collaboration.
	1 point – Applicant mentions minimal collaborative efforts in their project.
	3 points – Applicant mentions adequate collaborative efforts in their project.
	5 points – Applicant mentions multiple distinct collaborative efforts in the project.

HAS THE SUBGRANTEE BEEN	0 points – Yes
FUNDED BY SHSP IN THE PAST THREE YEARS?	5 points – No

IS THE APPLICANT A PART OF AN UNDERSERVED COMMUNITY?	0 points – Applicant is not a part of an underserved community.
	3 points – Applicant is a part of an underserved community but gave minimal explanation.
	5 points – Applicant is a part of an underserved community and gave good explanation of that in the application.

IS THE PROBLEM SIGNIFICANT ENOUGH TO WARRANT FUNDING?	0 points – Does not warrant funding, no connection to scope of the grant.
	1 point – Has minimal connection to scope of grant.
	2 points – Has a connection to grant, but it is weak.
	3 points – Has an adequate connection to scope but doesn't go above and beyond in application detail.
	4 points – Has a good connection to the scope of the grant.
	5 points – Goes above and beyond in the scope of the grant and goes in depth about the connection between the project and scope.
