FINAL ORDER OF THE FIRE PREVENTION AND BUILDING SAFETY COMMISSION

On April 17, 2025, Petitioner, Grateful Care ABA, appearing by counsel, Jeffrey Bellamy, and Respondent, White River Township Fire Department, appearing by counsel, Justin Olson, participated in oral arguments on the December 20, 2024, Non-Final Administrative Order issued by Administrative Law Judge Vanessa Voigt Gould ("Non-Final Order"), and the January 6, 2025, Objection to Non-Final Order filed by Respondent White River Township Fire Department. The Fire Prevention and Building Safety Commission ("Commission"), having considered the filings and arguments of the parties, finds that White River has not met its burden of persuasion and production. The Commission now **AFFIRMS**, without modification, the "Non-Final Administrative Decision" of the Administrative Law Judge.¹ The Commission is the ultimate authority, and this action is its final determination. A person who wishes to seek judicial review of this final determination must file a petition for review in an appropriate court within thirty (30) days of this notice and must otherwise comply with IC 4-21.5-5.
