Indiana Homeland Security Foundation Awards Scholarships to 18 Students

Eighteen Indiana students who serve in public safety organizations will receive scholarships from the Indiana Homeland Security Foundation to supplement their 2016-17 college education.

“Indiana is excited to offer the Secure Indiana Scholarships to support students who based the safety and well-being of others as a career focus,” said Ken Neumeister, Chair of the Indiana Homeland Security Foundation Board. “I applaud their commitment to service and to pursuing a higher education in public safety.”

Each student receiving a scholarship attends an Indiana college and has volunteer experience at a public safety organization such as emergency

medical services (EMS), emergency management agency (EMA), or a police or fire department. Students studying full-time receive a \$2,000 scholarship and students studying part-time receive a \$1,000 scholarship. The students must hold a grade point average of 2.8 or higher on a 4.0 scale.

“These students are obviously driven to serve and assist their fellow Hoosiers,” said Neumeister. “As the future of public safety, we are honored to help them achieve their education dreams.”

The funding for these scholarships was provided through purchases of “Secure Indiana” license plates. The Indiana Homeland Security Foundation also provides financial support for critical public safety needs across Indiana. The foundation offers the Secure Indiana Scholarship to provide higher education financial

assistance for Indiana students who wish to pursue a degree.

EMS Instructors Learn New Moulage Techniques



Certified Emergency Medical Services primary instructors from Indiana attended moulage techniques training courses in central Indiana on February 20-21. The courses were taught by instructors with Moulage Concepts, a company that assists medical professionals in creating realistic training scenarios, and were organized by the Indiana Department of Homeland Security.

The two-day courses were held at the Hamilton County Training Center and Franciscan Health in Greenwood.

Moulage is a technique where fake injuries are created on “patients” using makeup. The simulations help medical professionals train on providing aid to different types of injuries. The primary instructors are able to take the new techniques that they learned and teach their students in separate courses across the state. ■

Indiana River Rescue School Sessions Scheduled for May 8-12 and June 5-9



The St. Joseph River in South Bend is the site of the Indiana River Rescue School. The East Race waterway (to the right of the dam) is where the training takes place. Water can move very quickly through the East Race at 1500-2000 cubic feet per second.

The Indiana River Rescue School (IRRS) is holding two Operations/Technician level water rescue classes in South Bend from May 8-12 and from June 5-9. Students will learn about hazard recognition, risk assessment, water safety equipment, shore and boat-based operations and rescue techniques.

“Hoosiers love water,” said Captain Keith Dinn with the Indiana Department of Natural Resources and an IRRS board member. “Anywhere you have people in water, you have a potential for risk, and knowing how to identify and mitigate the risk is huge for any emergency responder.”

The five-day course costs \$600 (which includes books and lunches) and involves extensive

training on the St. Joseph River and the East Race Waterway, which allows for realistic but controlled training in water rescue.

“Our whole intent is to ensure that our responders, whoever they might be – firefighter, policeman, paramedic, EMT, show up to the scene of any water emergency and they don’t become a victim,” said Dinn.

Interested applicants should be in good physical condition, able to swim 300 meters nonstop (required to navigate class I–III rapids in approved personal flotation devices), capable of functioning as a member of a team and have some knowledge of ropes and knots.

After completing the course, Dinn said, students will “have the basic ingredients for so much more success, so much more

competence, and it’s what you take from there and how you expand upon it and how you train on it regularly, that’s how you become so much more competent, safe and capable.”

Based in South Bend, the Indiana River Rescue School was formed in 1983 through the cooperative efforts of the South Bend Parks and Recreation Department, the Indiana Department of Natural Resources, South Bend Fire Department, South Bend Police Department and the Ohio Department of Natural Resources. ■

In Brief

South Bend Fire Dept. Partners with Area Utility Companies to Conduct Underground Training

The South Bend Fire Department partnered with Indiana Michigan Power to conduct an underground confined spaces training in South Bend on March 28-30, 2017. With utility equipment often stored and used underground, the training served to help prepare the utility company on how to respond to an emergency that may happen in the 16-by-16 foot holes.

The South Bend Fire Department is also planning a similar training with the utility company NIPSCO in April. ▪

Paoli Fire Dept. Participates in “Home Fire Campaign”

The Paoli Fire Department participated in the Home Fire Campaign on April 2, 2017, partnering with the American Red Cross and Indiana University Health-Paoli. The campaign worked to install free smoke alarms in the area, with a goal to reduce death and injury caused by home fires by 25 percent by 2019. Volunteers also provided families with emergency escape plans and fire safety information. Smoke alarms greatly increase the chance of families surviving a home fire. ▪

Search and Rescue Conference April 21-23

Indiana Department of Homeland Security Search and Rescue and Gateway Search Dogs, Inc., will be co-hosting a search and rescue conference from April 21-23, 2017.

The conference, which will include area search, human remains detection, basic rope techniques and disaster training, will be held at Camp Atterbury in Edinburgh, Indiana.

Washington Township Fire Dept. Helps Train Area Professionals on Safe Digging

The Washington Township Fire Department in Northwest Indiana worked with the Indiana Utility Regulatory Commission and NIPSCO to educate professionals in the area on safe digging practices. Partners put on a live demonstration of a pipeline being hit on March 29, 2017.

The day-long event started with a classroom session on the importance of calling 811 before digging, and culminated in the live demonstration, where the Washington Township Fire Department helped respond. Although it is legal in Indiana to dig on your own property up to 12 inches, it is always important to call 811 before digging to ensure safety. ▪

Survey to Help Identify Training Courses for State Level Exercise

In response to communication from local partners, the scope of the Indiana Department of Homeland Security's State Level Exercise has been changed from a full scale event to training opportunities identified with assistance from participating districts.

To assist with identification of appropriate training, IDHS is asking partners to complete a survey by 5 p.m. April 21, 2017.

IDHS is now going to conduct position specific training classes during the State Level Exercise August 28-September 1, 2017, at Muscatatuck Urban Training Center. Participants will be

provided opportunities that they can take back to their respective jurisdictions to sustain the Incident Management Team (IMT) concept.

The 2017 State Level Exercise will prioritize IDHS districts 5, 6 and 7, but will also be open to emergency management and response professionals throughout the state, space allowing.

Training will be provided at no cost to the individuals taking a course. Lodging can be provided for participants who have to travel more than 50 miles. Participants should contact Elisabeth Westfall, State Training Officer, at ewestfall@dhs.in.gov, for assistance with setting up lodging.

EMAs Support Criminal Investigation in Delphi

White County and Tippecanoe County emergency management agencies (EMA) are two of several state, local and federal agencies to assist with the initial missing person search and now criminal investigation for the murders of two Delphi teens.

Due to the high visibility and size of the response, the EMAs provided a wide range of services to assist law enforcement: staffing, equipment and telecommunication services, and managing volunteer search parties, donations and tip lines.

"We were happy to help and there was an absolute need," said Smokey Anderson, Tippecanoe County EMA director. "We help each other out when we can."

White County and Tippecanoe County EMA both assisted in the missing person search, and Tippecanoe County EMA responded with a mobile command center from Purdue University, communications equipment, heating units and portable generators.

"Carroll County EMA is grateful to White County EMA and Tippecanoe County EMA for their assistance with this difficult situation," said Dana Jeffries, Carroll County EMA director. "Thanks to their additional staff and resources, Carroll County EMA was able to focus on other needs in the community."

Once the deceased were located, EMA efforts switched to supporting law enforcement partners in the criminal

investigation. White County EMA provided light towers for the crime scene, and both EMAs assisted with securing the perimeter of the scene.

"White County EMA is always ready to share any and all equipment to help out in any kind of incident... no matter how big or small," said Roberta York, White County EMA director.

As of February 28, more than 50 local, state and federal agencies had been involved in the investigation. ▪

Cities of Decatur and Fort Wayne to Purchase and Demolish Flood-Prone Properties

The cities of Decatur and Fort Wayne will soon begin projects to purchase and demolish the structures on 10 flood-prone properties after being awarded 676,860 in federal grants.

“These properties have experienced repetitive flooding and damage, resulting in recurring economic injury to the individual and family owners,” said Indiana Department of Homeland Security Executive Director Bryan Langley. “Purchasing these properties will take them out of harm’s way, and remove some of the financial and emotional stress from this community and these property owners.”

Each city has teamed up with the Maumee River Basin Commission to help contribute 25 percent of the \$902,480 total project cost.

The remaining 75 percent of the necessary funds were awarded by the U.S. Department of Homeland Security’s Federal Emergency Management Agency (FEMA). Indiana Department of Homeland Security will manage the grants and be the liaison among local government, organizations, homeowners and FEMA.

“The Pre-Disaster Mitigation program enables communities to implement critical mitigation measures to reduce or eliminate the risk of loss of life and property,” said Janet Odeshoo, acting regional administrator, FEMA Region V. “These projects will lessen the financial impact on individuals and the communities when future flooding occurs in this area.”

The City of Decatur property buyouts are for six flood-prone residential structures in the floodplain of the St. Marys River.

The City of Fort Wayne buyout is for four structures located in the Junk Ditch and St. Marys River floodplains. The 10 structures will be acquired, demolished and the properties returned to their natural state in perpetuity.

Rod Renkenberger, Executive Director of the Maumee River Basin Commission, said, “The Indiana Legislature created the Maumee River Basin Commission (MRBC) to reduce flood damage in northeast Indiana. With the strong support of our partners at the Indiana Department of Homeland Security, we will continue implementing flood buyout projects in Auburn, Decatur, and Fort Wayne. These projects represent one more step toward reaching the national, state and MRBC objective of making communities flood resilient.” ▪

The 4th Annual EMS Medical Directors’ Conference will be held Friday, April 28, 2017 from 8 a.m. to 4 p.m. at the Indianapolis Marriot North.

The Medical Directors’ Conference provides participants a venue to discuss the most up-to-date standards of care for emergency medicine, develop a strategy for practicing emergency medicine using those standards and to discuss the results of recent outcome-based research in pre-hospital emergency medical care.

EMS medical directors, paramedics, public safety officials, emergency department leadership and hospital administration are encouraged to attend. Current physicians and EMS professionals can receive continuing education credit by attending the conference.

However, more people die at low head dams than from the failure of dams themselves, showing the importance of education about these lovely, but dangerous structures. In the last 20 years, at least 24 Hoosiers have died at low head dams, and many more have needed rescue and treatment.
