WHAT WE STILL NEED TO COMPLETE:

1. ASME A17.6-2017 – Standard for Elevator Suspension, Compensation, and Governor Systems

• Perceived recommendation was to have the department (IDHS) staff bring forward a proposal to adopt ASME A17.6-2017 in its entirety without amendment, and provide the Committee some estimates on savings to the regulated public (and costs to the State) as a result on the decrease in need for variances (based on total variances filed and approved and/or permits issued to applicable lifting devices).

2. ASCE Automated People Mover Standard 21, 2013 Edition

3. ASME A17.3-2015 – Safety Code for Existing Elevators and Escalators

 At its first meeting in February 2018, the Committee determined that it would review and intend to adopt ASME A17.3-2015. At much later meetings in early 2020, before the Committee's meetings were put on hold due to the COVID-19 pandemic public health emergency and lack of staff resources, the Committee determined that it should review and intend to adopt the most recent edition – ASME A17.3-2017. ASME A17.3-2017 was published May 23, 2018 (5/23/2018).

1. Statutory Obligations to Review the Most Current Editions of the Model Codes

- Pursuant to IC 22-13-2-2(c), the Fire Prevention and Building Safety Commission (or its appointed subcommittee(s) by extension) is **required to** (shall) review the subsequent (most recent) edition of each code adopted under subsection (b) [IC 22-13-2-2(b)] within twenty-four (24) months after the effective date of the subsequent edition (most recent edition). Since the Committee began its work in early 2018, the following new editions of the model codes have been published:
 - a. ASME A17.1-2019 published/issued December 31, 2019 (12/31/2019)
 - b. ASME A17.3-2017 published/issued May 23, 2018 (5/23/2018)
 - c. ASME QEI-1-2018 published/issued October 11, 2018 (10/11/2018)
