- The Indiana Elevators, Escalators, Manlifts, and Hoists Safety Codes Committee (Committee), subcommittee of the Fire Prevention and Building Safety Commission (Commission), was called to order by Committee Chairman Michael Corey at 9:06 a.m. EST on Tuesday, December 15, 2020.

2. Roll Call/Attendance

Secretary Boyle conducted roll call noting that quorum was met with five (5) members in attendance. He also informed the Committee that he received a message from John Watson prior to the meeting stating that he would not be present.

- 3. Committee Staff Updates/Announcements
 - a. Status Update on Indiana Open Door Law and Public Meeting Requirements during the State of Indiana's COVID-19 Public Health Emergency – Douglas Boyle, Director of the Fire Prevention and Building Safety Commission & Justin Guedel, IDHS Deputy General Counsel

Secretary Boyle notified the Committee that Governor reissued the executive order and public health emergency on December 1, 2020. The General Assembly will be utilizing the Indiana Government North and South buildings, as well as the statehouse to conduct its business in January. Secretary Boyle stated this will make it very difficult for in-person meetings to be hosted; thus, the Committee should expect to continue meeting via WebEx through the first three to six weeks of 2021.

- 5. Continue Review of ASME A17.3-2017 [Next Steps for Rewriting 675 IAC 21-9 (Rule 9) and Incorporating ASME A17.3-2017 by reference]
 - a. Sections of ASME A17.3 retained and not amended in 675 IAC 21-9 prepared by Steve Stuard

Essentially, the Committee was tasked with looking over the newest edition of ASME A17.3 and deciding which sections to incorporate into the newest rewrite of Rule 9. Chairman Corey reminded the Committee that any new amendments or deletions would not result in a fiscal impact because each section is already being enforced in the current edition of Rule 9. Attached to the end of this document is the amended edition of 675 IAC 21-9 to reflect all changes decided on by the Committee.

Note: Unless explicitly stated otherwise, all other sections of the code will be retained as submitted by Steve Stuard.

 b. Proposal #114 – ASME A17.3-2017, Section 2.7 Hoistway – Door Locking Devices, Parking Devices and Access (Steve Stuard) – tabled at last month's meeting

After some brief deliberation, Steve Stuard informed the Committee that he was **withdrawing** the his proposal from the Committee's consideration.

c. Next Steps for finishing ASME A17.3-2017 and rewriting 675 IAC 21-9 (Rule 9)

Secretary Boyle advised the Committee that staff will work on preparing a document that incorporates that amendments of 675 IAC 21-9-2 (deleting sections of ASME A17.3-2005 without substitution or amending them) into the ASME A17.3-2017 model code text, to be presented and reviewed by the Committee at next month's meeting. In review of this document, the Committee will determine if the amendments provided should still be carried forward in their application to ASME A17.3-2017, as part of the Committee's new proposed rule.

6. Plan Forward

a. Set Meeting Date for January 2021

After some discussion, the Committee decided that it will tentatively plan to meet next on Tuesday, January 19, 2021. Secretary Boyle advised that format of the meeting – in person or electronic – will depend on if Governor Holcomb extends the State of Indiana's public health disaster emergency declaration again, along with the current modifications to the Indiana Open Door Law. Secretary Boyle advised that he expects the next meeting will again be conducted completely electronic via Cisco Webex, and the Committee can expect an update and confirmation by the beginning of January.
