- F. State Fire Marshal Report James Greeson
  - 1. Crane Shipping Containers- 50 are available if you need them. Their on a first come first serve basis. You can have them shipped to you for a fee, if not you will need to have a 20 feet flatbed truck.   - 2. Legislation- House Bill 1230 passed in May 2018. This bill entailed school safety. We will be providing "Guidelines" to the Department of Education by August 1<sup>st</sup> on recommendations for school safety. These will be published on the Department of Education, Indiana Department of Homeland Security, State Fire Chiefs Association, and IVFA website. Primarily what our recommendations will call for that schools use the grant money they will receive to put Alarm Panels that are capable of doing the positive alarm sequence. That schools put proper latches on school room doors. There will also need to be an "Active Shooter" drill within the

first twenty-five to forty-five (25-45) days of the start of the school year. The bill also allows for an "Unannounced Alarm" where the school has up to three (3) minutes to investigate and determine if it is an "Active Shooter" or situation where students need to "Seek Shelter in Place" or "Evacuate". Those are just some of the recommendations

- 3. Fire Board Rule re-write group met on July 24<sup>th</sup> -25<sup>th</sup>. To go through the Fire Board rules to see what needs to be updated. Our legal staff will put those updates into legal verbiage then they will be reviewed. The process is pretty lengthy. We have to get permission to move forward, it has to go to the Attorney General's office, and then we will have public hearings to receive the publics input. We will be putting more information on the IDHS website about upcoming events related to this.
- 4. Senate Bill 393 (Firefighter Safety Notification Law) it took effect July 1, 2018. It requires city, towns, or counties that have a Building Commissioner: On the application for a building permit the developer needs to identify the type of construction for a Class 1 or Class 2 structure. If lightweight construction weather it is the I-Beam, Floor Joist, or Truss Roof System it has to be noted. Within ninety (90) days of the permit being issued the Building Commissioner has to notify the fire department and the E911 center of the address and the type of construction that is going on. This will allow response teams to have pre-arrival instructions.
- 5. Indiana Fallen Fire Fighters Annual Recognition will be on September 7, 2018 at 11:00am. We will adding names from Carmel Fire Department, Lawrence Fire Department, Fort Wayne Fire Department, Greenfield Fire Territory, and Montgomery Volunteer Fire Department. There will also be six other historical names added. **Thomas Hanify:** Please come in uniform. If you do not want to come in uniform please still come to support the families.
- 6. Indiana Emergency Response Conference (IERC) will be held September 12<sup>th</sup> 16<sup>th</sup> at the Sheraton Hotel 8787 Keystone Crossing, Indianapolis, Indiana 46240. - G. Director of Training/Preparedness & Planning John Brown– None at this time
- H. Academy Administrator Charles Heflin
  - 1. Executive Leadership Program is on hold right now until we finish with the Crane Shipping Container Project.
  - 2. Fire Officer I Beta Program Subject matter experts have been revising the program. We have been working on aligning it with the IFSAC and NFPA requirements. It will still be a 40 hour program. This is more of a skills based course, instead of just a course and an examination. Each chapter will have a quiz but there will not be a final exam. There will be twelve (12) sessions, each student can miss no more than two (2) sessions. Students will have learning activities, discussions, and a chance to role play what they have learned. We will be submitting for a variance for these students to test out of order at the next board meeting.

**Mark Smythe**: Came to give the board an update on his variance request for Instructor 2/3 certification. He has completed all of the required skills and will be submitting documentation to the IDHS office for consideration at the September board meeting.

L. New Business –

John Smith: I have brought some concerns about the Hazardous Materials First Responder Awareness exam. There are a couple of questions that cannot be answered correctly with the 2016 ERG book. There is also a time difference with the amount of time allowed for testing. Students are reporting that they only have two (2) hours instead of three (3) hours to test. The Fire Board allows for three (3) hours to complete an exam. There is also the concern that twenty-five (25) questions on the Hazardous Materials First Responder Awareness exam does not leave room for error. Maybe there can be twenty-five (25) more questions added to give the students a better chance at passing.

Eric Dreiman: I heard you talking about this before the meeting, is this someth and John can work on to fix?

**Donna Saine:** I think he may have been issued an old version of that test. I will have to check into it to see if the time was wrong on any version. This is the first time I have heard of not being allowed three (3) hours to test.

**Thomas Hanify:** We use the reference material (ERG) during the test right? Increasing the number of the questions may make it more difficult if they have to look up more stuff. I do believe we need to make sure they are allowed 3 hours but I'm not sure about adding questions. Let us talk with a subject maters expert about adding questions.

**John Smith:** I can say we had scores all over the place. Some were in the 90's and some were in the 40's. It seems like the students that were using the 2012 ERG book had a better chance at passing. If staff is willing to look at this then I am satisfied with that.
