### AGREED ORDER AND STIPULATION OF DISMISSAL

The parties respectfully request the above captioned case be dismissed with prejudice. In support of this request, the parties state the following:

- 1. On 07/09/2024, Respondent issued an order (hereinafter 'order') to the Petitioner regarding an application for Emergency Technician (EMT) certification, which is the subject of this administrative review.
  - 2. To resolve this matter, the parties agree to the following:
    - a. Petitioner failed to follow examination procedures on her June 15, 2024, State EMT Practical Examination and that resulted in a FAIL for the 2A examination attempt.
    - b. Because that is the end of her testing cycle related to EMT Class #0303-2024, Petitioner has no further examination attempts.
    - c. Petitioner is eligible to re-enroll in an EMT (or EMR) program should she elect to do
    - d. The Original Order [S016-2024] will be rescinded by IDHS.
    - e. Petitioner dismisses her administrative appeal with prejudice.

WHEREFORE, the parties respectfully request this matter be dismissed with prejudice.

### **FINAL ORDER OF DISMISSAL**

On July 25, 2024, a Petition for Administrative Review was filed by Lina Rebidha Bouabid ("Petitioner") with Office of Administrative Law Proceedings (OALP) along with a request for a stay of effectiveness of the Department of Homeland Security (DHS) Findings and Order issued July 9, 2024, regarding Petitioner's application for Emergency Medical Technician (EMT) Certification, PSID #: 7436-6153. Pursuant to Indiana Code §§ 4-15-10.5-12, -13, OALP assigned the Hon. Vanessa Voigt Gould to serve as the ALJ over this matter.

On November 12, 2024, the parties filed an Agreed Order and Stipulation of Dismissal for the above-captioned matter. The Agreed Order and Stipulation of Dismissal resolves all issues relevant to this appeal, and in turn requests dismissal with prejudice of this appeal. The undersigned ALJ therefore issues this final order approving the Agreed Order and Stipulation of Dismissal, dismissing Petitioner's appeal with prejudice, and vacating all hearings and deadlines in this matter.

OALP is the Ultimate Authority for administrative reviews of actions taken by the Indiana Department of Homeland Security. Therefore, this is a final order by the Ultimate Authority in this case. A party who wishes to seek judicial review of this final agency action, must file a petition for review in an appropriate court within thirty (30) days of the date this Order was served. See Ind. Code § 4-21.5-5-5. Guidance for calculating deadlines may be found at Ind. Code § 4-21.5-3-2. Other requirements for a petition for judicial review may be found at Ind. Code Ch. 4-21.5-5.

A petition for judicial review must be served on the Office of Administrative Law Proceedings at oalp@oalp.in.gov to ensure the Office prepares the record that will be filed in the court presiding over the judicial review.
