#### PRESENTATION OF DESIGNEE FOR OPEN POSITION

#### a. Dr. Eric Yazel – Indiana State EMS Medical Director

# IN REVIEW OF STATE HOMELAND AND SECURITY PROGRAM (SHSP) FEDERAL AWARD LETTER

Rachel Cosner presented to the committee

## SHSP Requirements

- 1. Pass-through 80% / 20% split
- 2. Law Enforcement Terrorism Prevention Activities (LETPA)
  - a. 30% award
- 3. Funding Availability
  - a. 45 days
- 4. Senior Advisory Committee (SAC)

## **NATIONAL FUNDING PRIORITIES**

## Requirements – 30% of Award Across the National Priorities

- 1. Cybersecurity
  - 0% award \$0 encouraged but not required
- 2. Soft Target/Crowded Places
  - 3% minimum of award \$145,425.00
- 3. Information and Intelligence Sharing and Cooperation
  - 3% minimum of award \$145,425.00
- 4. Domestic Violent Extremism
  - 3% minimum of award \$145,425.00
- 5. Enhancing Community Preparedness and Resilience
  - 3% minimum of award \$145,425.00
- 6. Enhancing Election Security
  - 0% award \$0 encouraged but not required

Question from Steven Cain – "What if someone does not want the money that is allowed?" Rachel responded, "We talk to FEMA, and they let us know how to take care of that situation".

## Cybersecurity

Cybersecurity investments must support the security and functioning of critical infrastructure and core capabilities as they relate to preventing, preparing for, protecting against, or responding to acts of terrorism.

## Enhancing Protection

Soft targets and crowded places are increasingly appealing to terrorists. They are relatively accessible and there are many potential targets. This is complicated by the prevalent use of simple tactics and less sophisticated attacks. Public and private sectors should collaborate to enhance security.

## Information and Intelligence Sharing

#### Fusion Center

Cooperation and information sharing among state, federal and local partners across all areas of the homeland security enterprise, including counterterrorism, cybersecurity, border security, immigration enforcement and other areas is critical to homeland security operations and the prevention of, preparation for, protection against and responding to acts of terrorism.

#### Domestic Violent Extremism

Domestic violent extremism Investment Justification (IJ) must be in support of the state's efforts to combat the rise, influence and spread of domestic violent extremism.

## Community Preparedness and Resilience

Bolster community preparedness and resilience by investing in local, community-driven capabilities. It enables community organizations to have the capabilities to withstand acts of terrorism and provide essential services, especially to members of underserved communities, in the aftermath of an attack. It addresses the needs of underserved, atrisk communities to help ensure consistent and systematic, fair, just, and impartial treatment of all individuals before, during, and after a disaster.

## Enhancing Election Security

Securing election infrastructure and ensuring an election free from foreign interference are national security priorities. Threats to election systems requires constant vigilance, innovation, and adaptation.

#### ADDRESSING THE NATIONAL PRIORITIES

#### Priority Funding Info Bulletin

- Send IB to local applicants to address these national priorities and local priorities
- Purpose of the IB is to solicit local applications
  - a. Attempting to meet five of the priority investment justifications to help meet the 80% / 20% pass-through requirement.
- Applications were reviewed based on fit of terrorism nexus, national priority and Indiana core capability ranking.
- Projects were capped at \$150,000.00 for all projects
  - a. Allows more projects and more equity
  - b. Also minimum per IJ is lower allowing caps to be lower and still meet IJ minimums
- Only one priority application and one nonpriority application per organization

- a. Two total applications per organization
- Local applications were due June 1, 2022

## Applications Received Breakdown

Received 109 applications total

- 77 Priority applications
- 32 Non-Priority applications
- Total amount requested: \$13,038,229.79

## Applications Review Process

- Each application was reviewed by three reviewers by the approved rubric and the totals were averaged.
- The applications were then ranked by score for each IJ and evaluated for the best fit of the IJ.
- Finally, all communications projects were reviewed by the Statewide Interoperability Coordinator as outlined on page 32 of the Homeland Security Grant Program Notice of Funding Opportunity and all cyber projects were reviewed by the Indiana Office of Technology.

## SHSP Funding Breakdown
