However, if an LEPC has an exercise, only federally grant funded exercises are required to be reviewed for HSEEP compliance.	LEPC exercise An exercise proposal and the performance of an exercise is again required to be eligible to receive compliance from the IERC. If the exercise is federally grant funded, it is required to go through HSEEP compliance review.
