Remarks:

Timber is marked in red paint. At least one member of the logging crew must have completed at least Cutter 1 of the GOL training and the BMP training requirement in order to qualify under the state's certification requirements. Due to fast moving traffic on State Road 62, the use of warning

signs to alert drivers of flaggers and/or trucks entering the highway will be required. Loggers will need to direct traffic while felling trees that could cause debris to fall on the roadway.
