How to Submit a Bid:

Bidders must submit a check for an amount equal to or larger than 5% of their bid amount payable to the IDNR with their bid as a performance deposit. The timber will be sold to the highest bidder, provided the bid is acceptable to the state. The Department reserves the right to accept and/or reject any and/or all bids.

Terms of Sale:

10% down payment required within 14 days of sale date. Full payment can be made within 14 days of sale. If down payment method is used balance of payment is due within 1 year of sale date or prior to start of harvest operation, whichever occurs first. Or this remaining bid amount may be paid in installment payments, with respective installment payments due prior to the start of harvest operations in respective harvest areas, with the entire bid amount due within one year of the bid opening.

Where to Bid:

Sealed bids must be at the Ferdinand State Forest office at the time of public bid opening. No phone bids excepted.

Remarks:

Timber marked in blue paint. The boundary opening marked in yellow paint. At least one member of the logging crew must have completed at least Cutter 1 of the GOL training and the BMP training requirement in order to qualify under the state's certification requirements. Several trails run through

the sale area. The buyer is responsible for clearing logging debris from trails upon harvest completion. Logging activities may not occur within 300 feet of the family campground or Pike shelterhouse in tract 1202 from the Thursday before Memorial Day until the Tuesday after. Loggers will need to direct traffic while felling trees near roadways. Directional felling required. This is timber sale # 6311504. Sale maps are available at office and may be emailed or faxed upon request.
