#### Where to Bid:

Sealed bids must be at the Ferdinand State Forest office at the time of public bid opening.

#### **Remarks:**

Timber is marked in red paint. At least one member of the logging crew must have completed at least Cutter 1 of the GOL training and the BMP training requirement in order to qualify under the state's certification requirements. Additionally, at least one member of logging crew, possessing above certifications, must be present during harvest operations at all times. Loggers will need to direct traffic while felling trees next to county road. Directional felling required. This is Timber Sale
