Haul roads to be graded and smoothed to original condition.

Remarks:

All trees marked with blue paint. Skid trails have been pre-constructed in spoil bank areas only, and all yards are new locations. Directional felling is required and damage to residual trees from both felling and skidding should be minimized. Pre-harvest conference must be attended prior to the start of logging operations. The haul roads must be maintained and kept clear of all logging debris.

Logger will need to provide a flagger when operations may pose danger to motorists on adjacent roads. Also, logger needs to coordinate with utility companies when felling trees next to right of ways (only a very few trees, south and west edge of tract). Utility company may wish to fell trees themselves. **There is an estimated 217 board feet of prime volume in 3 black walnut trees**
