The sale has the following conditions:

All trees are marked with blue paint. Regeneration opening boundary trees are marked with red paint. Logger training to meet forest certification is required. A pre-harvest conference must be attended prior to the start of any logging operations. The buyer should coordinate with the electric company for any trees that could impact power lines. A spotter should stop traffic on Bucktown, CR 500S, and Highway 159 when trees are felled that could cause logging debris to fall in the road. The horse trails and haul roads must be maintained and kept clear of all logging debris. Directional felling is required. **LOGGING IN UNITS 2 & 3 (SEE MAP) MUST OCCUR BETWEEN NOVEMBER 1 – MARCH 31.**

The timber specified in this document is Certified Wood. Indiana State Forests are certified by both the Sustainable Forestry Initiative (SFI) and the Forest Stewardship Council (FSC). Purchasers of State Forest timber may market state forest timber products as certified if they have the appropriate Chain of Custody certificate.

The FSC Certificate Number for Indiana State Forests is SCS-FM/COC-00099N. The FSC claim is "FSC 100%".

The SFI Certificate Number for Indiana State Forests is NSF-SFIS-6L841-S1.

Sealed bid for such property will be received at the office of the Property Manager until the hour and date above set out, at which time and place all acceptable bids will be publicly opened and read aloud, and any bids received after the designated time will be returned unopened.
