*\* Volumes were estimated using a 20 BAF prism in 15 randomly located plots within 3 openings totaling 4 acres. None of these trees are painted, but all trees within these opening boundaries, except those marked with purple paint, are part of the sale.*

The sale has the following conditions:

All trees are marked with blue paint. Regeneration opening boundary trees are marked with red paint. Logger training to meet forest certification is required. A pre-harvest conference must be attended prior to the start of any logging operations. Flagger should be present to direct/stop traffic when felling trees along public roads. Horse trails in sale area will be closed for riding during operations but spotter should still be present when logging/skidding in trail areas. The haul roads and horse trails must be maintained and kept clear of all logging debris. Directional felling is required. BMPs required; log yards to be seeded and strawed and skid trails properly closed out upon completion of operations.

The timber specified in this document is Certified Wood. Indiana State Forests are certified by both the Sustainable Forestry Initiative (SFI) and the Forest Stewardship Council (FSC). Purchasers of State Forest timber may market state forest timber products as certified if they have the appropriate Chain of Custody certificate.

The FSC Certificate Number for Indiana State Forests is SCS-FM/COC-00099N. The FSC claim is "FSC 100%".

The SFI Certificate Number for Indiana State Forests is NSF-SFIS-6L841-S1.

Sealed bid for such property will be received at the office of the Property Manager until the hour and date above set out, at which time and place all acceptable bids will be publicly opened and read aloud, and any bids received after the designated time will be returned unopened.

Bidders are required to submit a check (completely filled out) for an amount equal to or larger
