BMP Explanation:

Also, an operational bulldozer must be on site during course of active skidding for cleanup of skid trails. Buyer will be required to seed and straw the log yard and major skid trails at the forester's discretion.

Cutting and skidding must take place before March 31, 2015 and/or between November 16, 2015 through March 31, 2016, and/or between November 16, 2016 through March 31, 2017. Logs in yard may be moved at all times of the year up until June 1, 2017. Den trees and large snags are marked with pink D's and S's. Two log yards located along fire trail. At least one member of the logging crew must have completed at least Cutter 1 of the GOL training and the BMP training requirement in order to qualify under the state's certification requirements.
