The sale has the following conditions:

Cutting and skidding must take place from November 16, 2014 through March 31, 2015 and/or from November 16, 2015 to March 31, 2016. Logs in yard may be moved at all times of the year up until June 1, 2016. This sale is not eligible for the partial payment plan. Skidding along the fire trail will not be allowed. Buyer will be required to seed and straw the log yard(s) and major skid trails at the forester's discretion. There must be an operational dozer on site during course of active skidding on sale area for cleanup of skid trails. Crushed stone or work needed on the haul road at time operation begins is the obligation of the Buyer. Boundary area marked with blue paint. These blue marked trees are not included in harvest. Areas around 2 cultural sites, sinkholes, and a spring are to be avoided. At least one member of the logging crew must have completed at least Cutter 1 of the GOL training and the BMP training requirement in order to qualify under the state's certification requirements.

The timber specified in this document is Certified Wood. Indiana State Forests are certified by both the Sustainable Forestry Initiative (SFI) and the Forest Stewardship Council (FSC). Purchasers of State Forest timber may market state forest timber products as certified if they have the appropriate Chain of Custody certificate.

The FSC Certificate Number for Indiana State Forests is SCS-FM/COC-00099N. The FSC claim is "FSC 100%".
