### **BMP Explanation:**

Standard BMP's will be required - directional felling, careful skidding to avoid damage to unmarked trees, avoidance of sinkholes and riparian areas. Also, an operational bulldozer must be on site during course of active skidding for cleanup of skid trails. Buyer will be required to seed and straw the log yard and major skid trails at the forester's discretion. Cutoff pile at yard will need to be scattered down due to proximity to scenic overlook with cabin.

#### How to Submit a Bid:

DNR will accept sealed bids. Bidders must submit a check for at least 5% of their bid amount (to IDNR) as a damage deposit along with their bid. The winning bidder must also make a payment at least 10% of the bid amount within 14 calendar days of the bid opening as a down payment. Terms of the sale will be cash, the buyer to accept delivery of the property and to remove the property there from by June 1, 2019, which will be the expiration date of said contract. The Department reserves the right to accept and/or reject any and/or all bids. The Department reserves the right to rebid the sale.

#### Where to Bid:

Public bid opening will be at the Harrison Crawford State Forest Office at 7240 Old Forest Road SW, Corydon, IN. Office is located at maintenance complex.

#### Remarks:

Trees are marked with blue paint. Cutting and skidding must take place from November 16, 2017 through March 31, 2018 and/or November 16, 2018 through March 31, 2019. Logs in yard may be moved at all times of the year up until June 1, 2019. Den trees and large snags are marked with pink D's and S's. Two log yard locations along fire trail – main yard by cabin – not cleared off. At least one member of the logging crew must have completed at least Cutter 1 of the GOL training and the BMP training requirement in order to qualify under the state's certification requirements. Most ash trees still have majority live crowns as of spring 2017. Sale can be split into 2 partial payment areas.
