Cutting and skidding is only allowed from October 1st through March 31st of each calendar year unless otherwise agreed upon in writing by both parties. Logs in the yard may be moved at any time of the year. The Buyer will provide an operational bulldozer on site at all times during active operations. Buyer may be required to provide additional stone if needed. A pre-harvest conference must be attended prior to the start of any logging operations. A spotter should stop traffic on Farr

Road when trees are felled that could cause logging debris to fall in the road. Logger is required to seed major skid trails and to seed and straw log yards. Administering forester must be present when harvesting trees within 100 feet of cultural features.
