

The sale has the following conditions:

This sale is two adjacent tracts. Access to timber may require a portable bridge. Additional access may be negotiated through adjacent landowner. Grapple skidders are only allowed on primary skid trail. Directional felling required. Access road and landing must be maintained and returned to pre-harvest condition. Logger is required to seed and straw log yard according to State Forest requirements. Logger must provide State Forest with seed tags. Logging will only be allowed during stable soil conditions. A pre-harvest conference must be attended prior to the start of any logging operations. Purchase of state forest timber sales require that at least one person (crew and/or supervisor) be on an active site at all times and have at least Indiana Cutter Level 1 and Introduction to BMP training both within the past 3 years. Sale area must be maintained and closed out according to Indiana Logging and Forestry Best management Practices (BMP) Guidelines. Mail-in bids are accepted and encouraged for this sale. Sealed bid for such property will be received at the office of the Property Manager until the hour and date above set out, at which time and place all acceptable bids will be publicly opened and read aloud, and any bids received after the designated time will be returned unopened.

Bidders in good standing are required to submit a check (completely filled out) for an amount equal to or larger than five percent (5%) of their bid amount payable to the Indiana Department of Natural Resources with their bid as a performance deposit. Bidders not in good standing are required to submit a performance deposit for an amount equal to or larger than 10% or 20% of their bid, depending on the level of their standing as provided to them by the Indiana Department of Natural Resources.
