Trees are marked in blue paint. Access to timber is good. Directional felling required. Logger must contact and cooperate with Cinergy before felling any trees marked along electric utility ROW.

Logger must not disturb sensitive area and will be required to cable some trees away from sensitive area while not causing any ground disturbance. No Grapple skidders allowed. A pre-harvest conference must be attended prior to the start of any logging operations. Purchase of state forest timber sales require that at least one person (timber buyer, supervisor, or crew member) have the minimum of Game of Logging (GOL) Level 1 Cutter Training and Introduction to BMPs.
