and straw log yard. Logger must contact Resource Specialist for seed requirements. Logger must provide forester with seed tags. Logging will only be allowed during stable soil conditions. No Grapple skidders allowed. A pre-harvest conference must be attended prior to the start of any logging operations. Purchase of state forest timber sales require that at least one person (timber buyer, supervisor, or crew member) have the minimum of Game of Logging (GOL) Level 1 Cutter Training and Introduction to BMPs. Sale area must be closed out according to Indiana BMP guidelines.
