moving into second unit. Buyer to provide dozer on site during harvest. A preharvest conference required prior to harvesting timber. Directional felling required. Grapple skidders allowed on major skid trails only. Marked timber is in generally infested EAB quarantine area. The harvest and movement of ash products will require compliance agreement with the IN Division of Entomology. Timber felled near public roadways will require road spotters. Tops to be removed from wildlife openings.
