The main block of the harvest area (140 acres) contains an abundance of small diameter trees - hence the low per tree volume average for White oak and Chestnut oak. 2 log yards are available for this block, however one yard does not have good access for semis. This sale also includes two 10-

acre shelterwood cuts, each has a separate log yard. Shelterwood "A" will average .2 to .4 mile skids to yard. And the yard is 1.8 miles off the county road. Shelterwood "B" will average .2 to .4 mile skids to yard. And the yard is 0.2 miles off the county road. Please note the harvest restriction dates.
