harvesting trees that could cause debris to fall on the roadways. All tree felling must occur between October 1 and March 31 of each year unless otherwise agreed upon in writing by both parties. Logs in yard may be moved at any time of year. Operator will provide an operational bulldozer on site at all times during active harvesting operations. Logger required to seed and straw log yards.
