Indiana Department of Education 2014-2015 Parent Survey—Indicator 8

ORGANIZATION OF THE RESEARCH SAMPLE

Whereas once it was sufficient for states to simply conduct a survey to gauge parent satisfaction, this is no longer the case. The Annual Performance Report (APR) and State Performance Plan (SPP) Indicator 8 requires that states initiate a process that utilizes contemporary survey methodology to systematically collect, analyze, and report data selected from a representative sample. The primary aim of this process is to assess the extent to which "schools" (e.g., special and general educators and administrators) have facilitated the involvement of parents in their child's educational program (e.g., parent conferences, IEP meetings).

Overall, the project involved three general phases of activity. The first phase of the project revolved around the initial project planning and design activities. The second phase involved the administration of the Parent Survey to parents throughout the state, and the third phase of the project centered on the data analysis and report generation activities.

DEVELOPMENT OF THE SURVEY QUESTIONNAIRE

For the 2014-15 Parent Survey, the questionnaire was modified to better meet the informational and data needs of IDOE by using the input from stakeholders to increase response rate. The format was changed to a "Yes / No" format and Not Applicable/NA for questions for which NA applied. The survey was shortened and the questions were modified to a more "parent friendly" language based on input from one of our major stakeholders for parent involvement, the Indiana Resource Center for Families with Special Needs (IN*SOURCE).

SURVEY ADMINISTRATION

The population of parents of students with disabilities has traditionally been difficult to reach and gain their participation in such surveys which limits the potential of parent feedback. For this reason, the Indiana Department of Education determined starting in January 2015, the administration of the parent survey, would be offered to parents at the Annual Case Review (ACR). The survey is available through the electronic IEP system which is used during the ACR.

Parents are provided two options for responding to the survey. These surveys are available in English and Spanish. The parent can complete the web-based survey immediately following the

ACR at the school or at home, or the parent has an option to request a paper copy from the Indiana Department of Education. A parent letter is available to send home for those who are unable to attend the ACR in person that contains information about how to access the parent survey.

SURVEY RESPONSE RATES

Overall, Indiana has 172,751 parents whose children received special education services during the 2014-2015 academic year. A total of 7,786 parents completed a usable survey for an overall response rate of 4.51%. A detailed breakdown of the 2014-2015 survey response rates follow.
