INDIANA SCHOOL CHOICE SCHOLARSHIP PROGRAM HISTORY

This document is the 2016 update to the Choice Scholarship Program Annual Report, originally released on January 27, 2014. This version of the report includes updates for the 2014-2015 and 2015-2016 school years.

The report provides an overview of the Indiana Choice Scholarship Program, which was passed as part of House Enrolled Act 1003-2011 (Public Law 92-2011) and provides Choice Scholarships to students in households that meet income and eligibility requirements. The program provides funds to assist with the payment of tuition and fees at a participating Choice School.

For the 2011-2012 school year, Choice Scholarships were limited to 7,500 students. For the 2012-2013 school year, Choice Scholarships were limited to 15,000 students. Beginning with the 2013-2014 school year, the student cap was removed and Choice Scholarships were available to any student that met eligibility and income requirements. During the 2013 Session of the Indiana General Assembly, the program was further expanded to include eligibility components related to special education, siblings, and failing schools.

ELIGIBILITY

To participate in the Choice Scholarship Program, a student must satisfy income and eligibility requirements.

STUDENT ELIGIBILITY CRITERIA

All students must satisfy the following three requirements:

1. Have legal settlement in Indiana;
2. Be between the ages of 5 and 22 no later than August 1 of the school year; and
3. Be accepted for enrollment into a participating Choice Scholarship school;

After satisfying the three requirements listed above, a student must satisfy the requirements for one of the eligibility pathways.

For the 2011-2012 school year, there were two eligibility pathways.

1. **Two Semesters in Public School Pathway**

- a. The student was enrolled in 1st through 12th grade in a public school, including a charter school, in Indiana for at least two semesters immediately preceding the first semester for which the individual receives a Choice Scholarship.
- b. Beginning with the 2013-2014 school year, kindergarten attendance could satisfy the two semesters in public school requirement.
- c. The student is a member of a household with an annual income equal to or below 150% of the amount to qualify for the Federal Free or Reduced Lunch Program.

2. Previous Scholarship Granting Organization (SGO) Award Pathway

- a. The student received a SGO Scholarship in a previous school year, including a school year that does not immediately precede the school year for which the student is applying for a Choice Scholarship.
- b. The six approved Scholarship Granting Organizations (SGOs) are:
 - Elkhart County Community Foundation
 - Institute for Quality Education, Inc. (Formerly Educational Choice Charitable Trust)
 - School Scholarship Granting Organization of Northeast Indiana
 - Tuition Assistance Fund of Southwestern Indiana (Closed February 2013)
 - Sagamore Institute Scholarships for Education Choice
 - The Lutheran Scholarship Granting Organization of Indiana
- c. The student is a member of a household with an annual income equal to or below 150% of the amount to qualify for the Federal Free or Reduced Lunch Program.

For the 2012-2013 school year, a third pathway, the Previous Choice Scholarship Student Pathway, became applicable. The Previous Choice Scholarship Student Pathway was written into the original statute. However, because the 2011-2012 school year was the first year of the Choice Scholarship Program, no student could have met the criteria for this pathway prior to the 2012-2013 school year.

3. Previous Choice Scholarship Student Pathway

- a. **2012-2013 School Year**
 - The student received a Choice Scholarship in the previous school year.
- b. **2013-2014 School Year**
 - The student received a Choice Scholarship in a school year that does not immediately precede the school year for which the student is applying for a Choice Scholarship; or
 - The student received a Choice Scholarship in the immediately preceding school year but the student exited the Choice School prior to the end of the school year.
- c. The student is a member of a household with an annual income equal to or below 150% of the amount to qualify for the Federal Free or Reduced Lunch Program.

For the 2013-2014 school year, legislative changes increased the number of eligibility pathways to seven.

4. Continuing Choice Scholarship Student Pathway

- a. The student received a Choice Scholarship in the school year that immediately precedes the school year for which the student is applying for a Choice Scholarship.
- b. The student is required to have remained enrolled at the Choice School for the entirety of the immediately preceding school year.
- c. The student is a member of a household with an annual income equal to or below 200% of the amount to qualify for the Federal Free or Reduced Lunch Program.

5. **Special Education Pathway**

- a. The student has a disability that requires special education.
- b. An Individualized Education Program (IEP) pursuant to IC 20-35 or a service plan pursuant to 511 IAC 7-34 has been developed for the student.
- c. The student is a member of a household with an annual income equal to or below 200% of the amount to qualify for the Federal Free or Reduced Lunch Program.

6. **“F” Public School Pathway**

- a. The student would be required to attend a specific public school based on his/her residence that has been assigned an “F” grade.
- b. This pathway does not require prior attendance at the school.
- c. The student is a member of a household with an annual income equal to or below 150% of the amount to qualify for the Federal Free or Reduced Lunch Program.

7. **Sibling Pathway**

- a. The sibling of the newly applying student received either a Choice Scholarship or an SGO scholarship in a preceding school year, including a school year that does not immediately precede the school year for which the student is applying for a Choice Scholarship.
- b. For purposes of the Choice Scholarship Program, the term “sibling” shall mean one of two or more individuals having one or both parents, guardians or custodians in common. The term does not require a consanguineous (blood) relationship between the individuals.
- c. The student is a member of a household with an annual income equal to or below 150% of the amount to qualify for the Federal Free or Reduced Lunch Program.

INCOME ELIGIBILITY CRITERIA

The income criteria to participate in the Choice Scholarship Program are linked to the Federal Free or Reduced Lunch Program income guidelines. In order to qualify for the 90% Choice Scholarship award, a student must be a member of a household with an annual income equal to or less than 100% of the amount to qualify for the Federal Free or Reduced Lunch Program. To qualify for the 50% award, the student must be a member of a household with an annual income equal to or less than 150% of the amount to qualify for the Federal Free or Reduced Lunch Program.

Beginning with the 2013-2014 school year, income eligibility for the 50% award was expanded to 200% of the amount to qualify for the Federal Free or Reduced Lunch Program for students qualifying under the Continuing Choice and Special Education Pathways.

PARTICIPATION

STUDENT AND SCHOOL PARTICIPATION

In 2011-2012, the first year of the Choice Scholarship Program, 3,911 students and 241 schools participated. Since the 2011-2012 school year, the program has grown each year. For the current school year, 2015-2016, 32,686 students and 316 schools are participating in the program. Tables 2 and 3 show the growth in student and school participation over the first four years of the program.

Statewide student enrollment counts by school type are provided in Tables 4a and 4b. Choice Scholarship Students have increased from 0.40% of total student enrollment in the 2011-2012 school year to 2.89% in the 2015-2016 school year.

PARTICIPATION BY GRADE LEVEL

For the first two years of the Choice Scholarship Program, students in grades 1 through 12 were eligible to participate. Beginning with the 2013-2014 school year, kindergarten students were eligible to participate. Tables 5a and 5b illustrate program participation by grade level cluster.

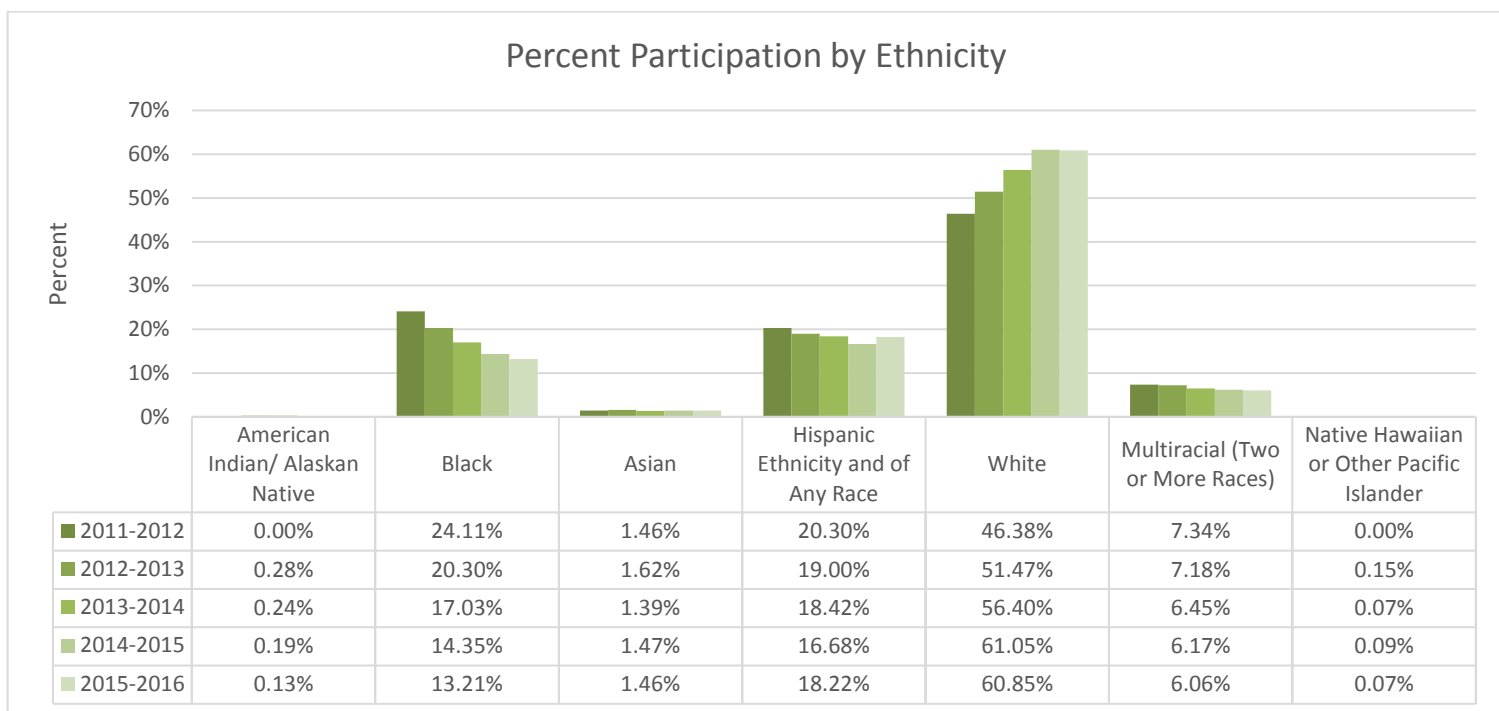

The participation of Black, American Indian/Alaskan Native, and Multiracial students as a percentage of total program participants has decreased in each of the five years of the program.



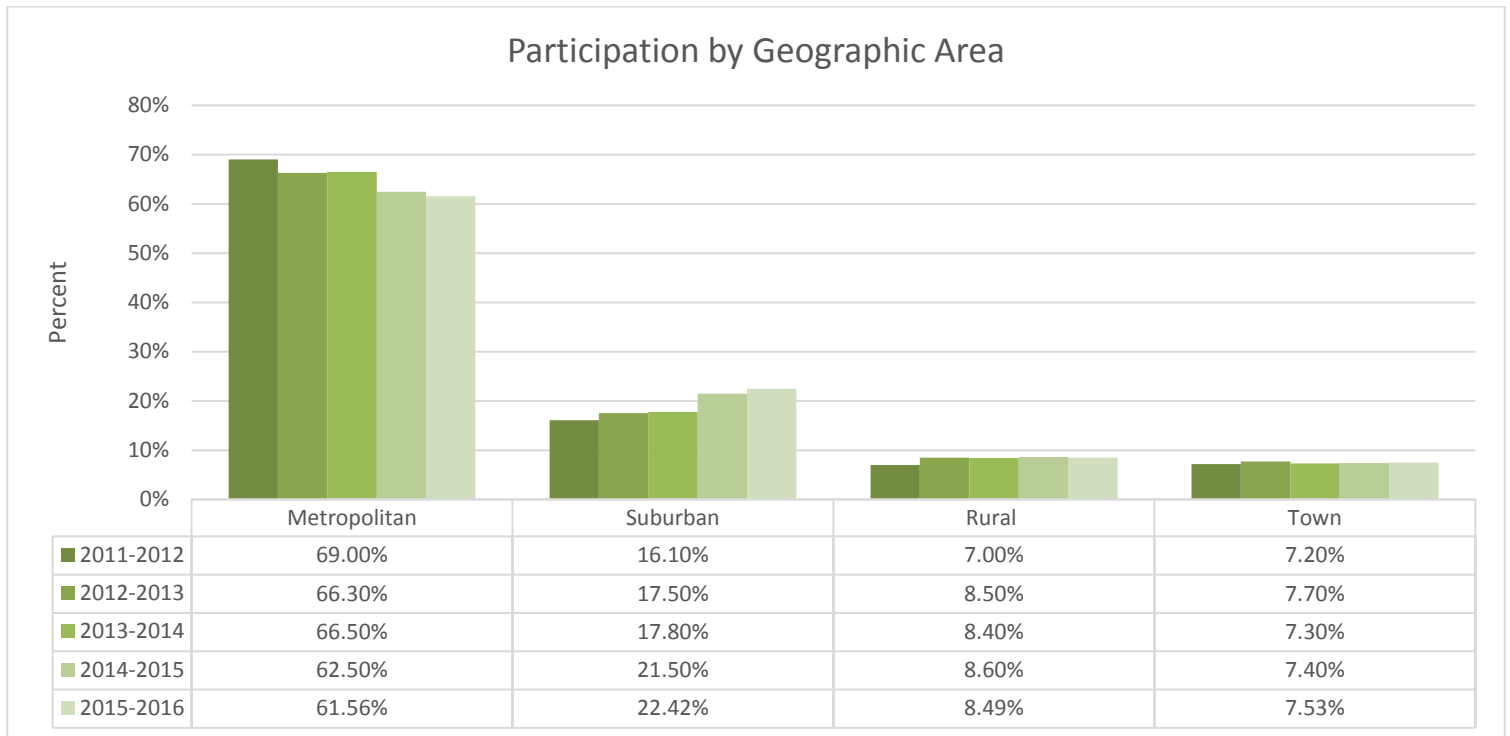
PARTICIPATION BY GEOGRAPHIC AREA

Each school corporation in Indiana is categorized as one of four geographic types- metropolitan, suburban, rural, or town. The geographic type of the school corporation of legal settlement is used to determine the geographic area of each student participating in the Choice Scholarship Program. As illustrated in Tables 9a and 9b, the percentage distribution of students by geographic area category has remained relatively consistent across the five years of the program.

The majority of Choice Scholarship students, 61.56% in 2015-2016, come from metropolitan areas. The percent of participants from suburban areas has increased in each of the five years of the program.



Pathways

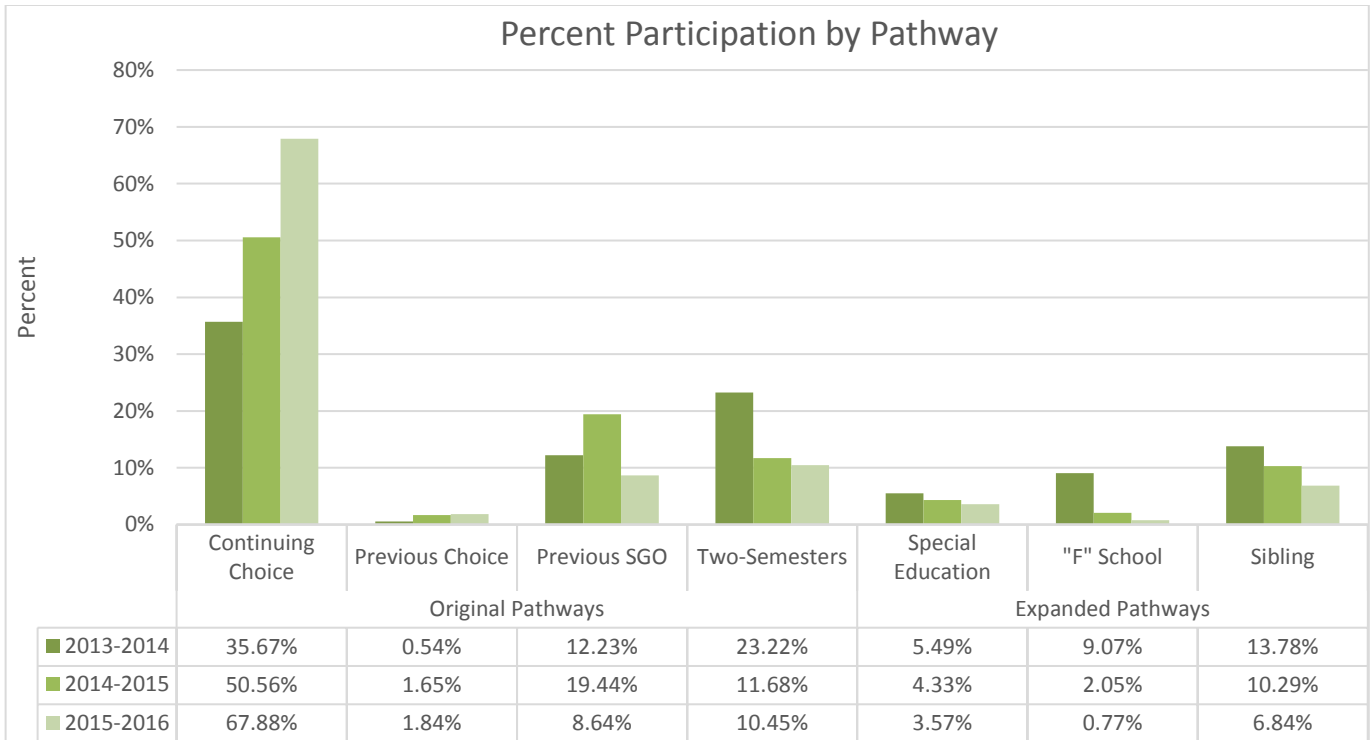
PARTICIPATION BY PATHWAY

For the 2011-2012 and 2012-2013 school years, there were three pathways to student eligibility. 1) A student spent two semesters preceding the receipt of a Choice Scholarship in an Indiana public school. 2) A student received an award from an approved Scholarship Granting Organization (SGO) through the School Scholarship Tax Credit Program in a previous school year. 3) A student received a Choice Scholarship award in a previous year. This requirement went into effect for the 2012-2013 school year.

Beginning with the 2013-2014 school year, student eligibility criteria for the Choice Scholarship Program was expanded to include seven different pathways to eligibility. Table 10 depicts the pathway selected at the time of student application. A student could satisfy the eligibility criteria of more than one pathway.

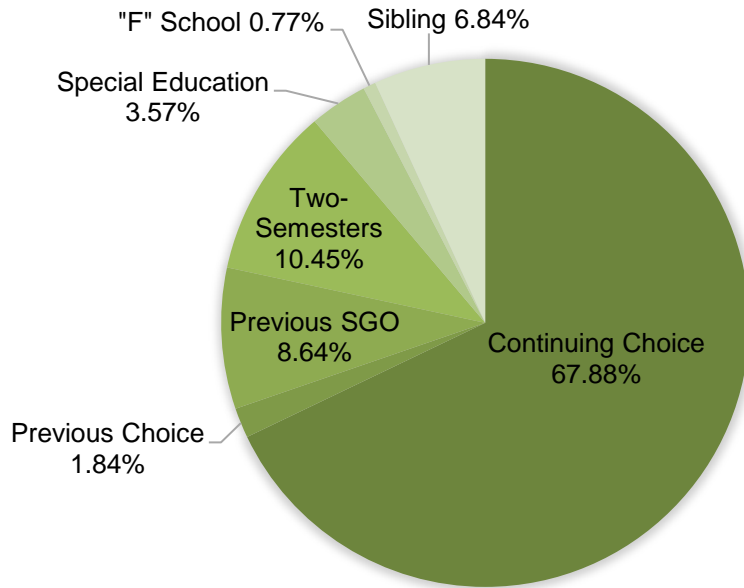

The percentage of students applying under the Continuing Choice Pathway increased from 50.56% in the 2014-2015 school year to 67.88% in the 2015-2016 school year. The Previous Choice Pathway had the second largest increase in the percentage of student applications increasing from 1.65% to 1.84%. All other pathways experienced a decline in the percentage of student applicants.



The Previous SGO, Special Education, "F" School, and Sibling Pathways were the only pathways that experienced a decline in the number of applicants between the 2014-2015 and 2015-2016 school years. In the 2014-2015 school year, 5,667 students applied under the Previous SGO Pathway while only 2,825 students applied under this pathway for the 2015-2016 school year. In the 2014-2015 school year, 1,262 students applied under the Special Education Pathway while only 1,166 students applied under this pathway for the 2015-2016 school year. In the 2014-2015 school year, 597 students applied under the "F" School Pathway while only 251 students applied under the this pathway for the 2015-2016 school year. Similarly, in the 2014-2015 school year, 2,998 students applied under the Sibling Pathway while only 2,237 students applied under this pathway for the 2015-2016 school year.

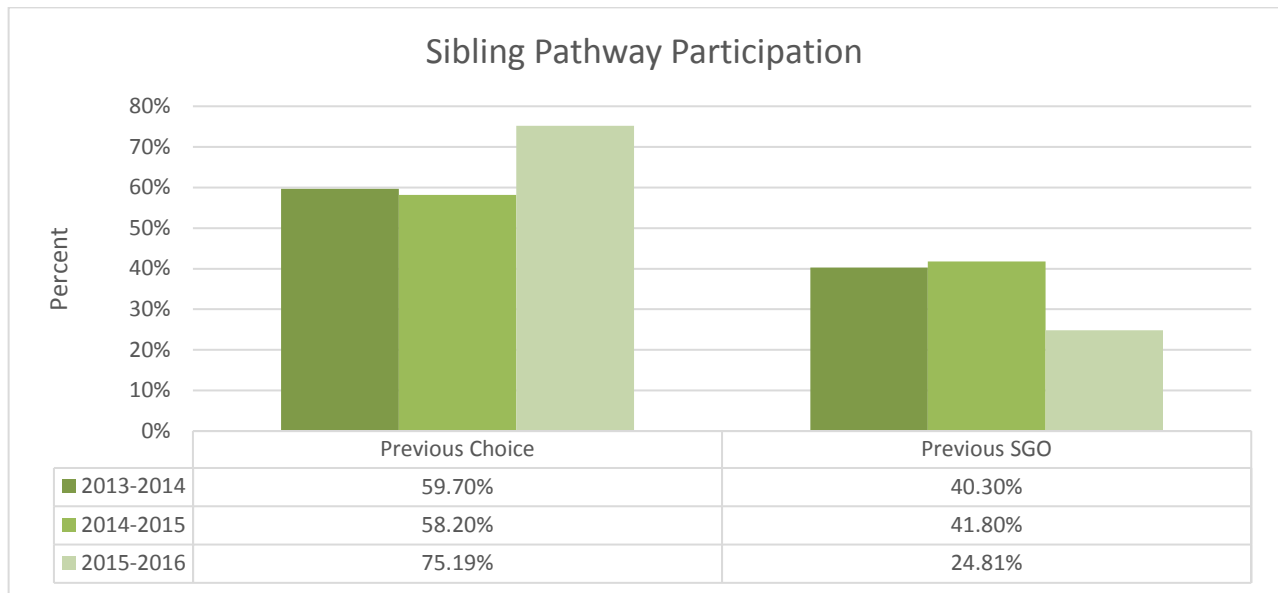
2015-2016 Participation by Pathway



There are two eligibility branches within the Sibling Pathway. A sibling of a student who received either a Choice Scholarship or an SGO Award in a previous school year is eligible under the Sibling Pathway. As illustrated in Tables 11a and 11b, the majority, 75.19%, of students who applied under the Sibling Pathway were siblings of previous Choice Scholarship Students.

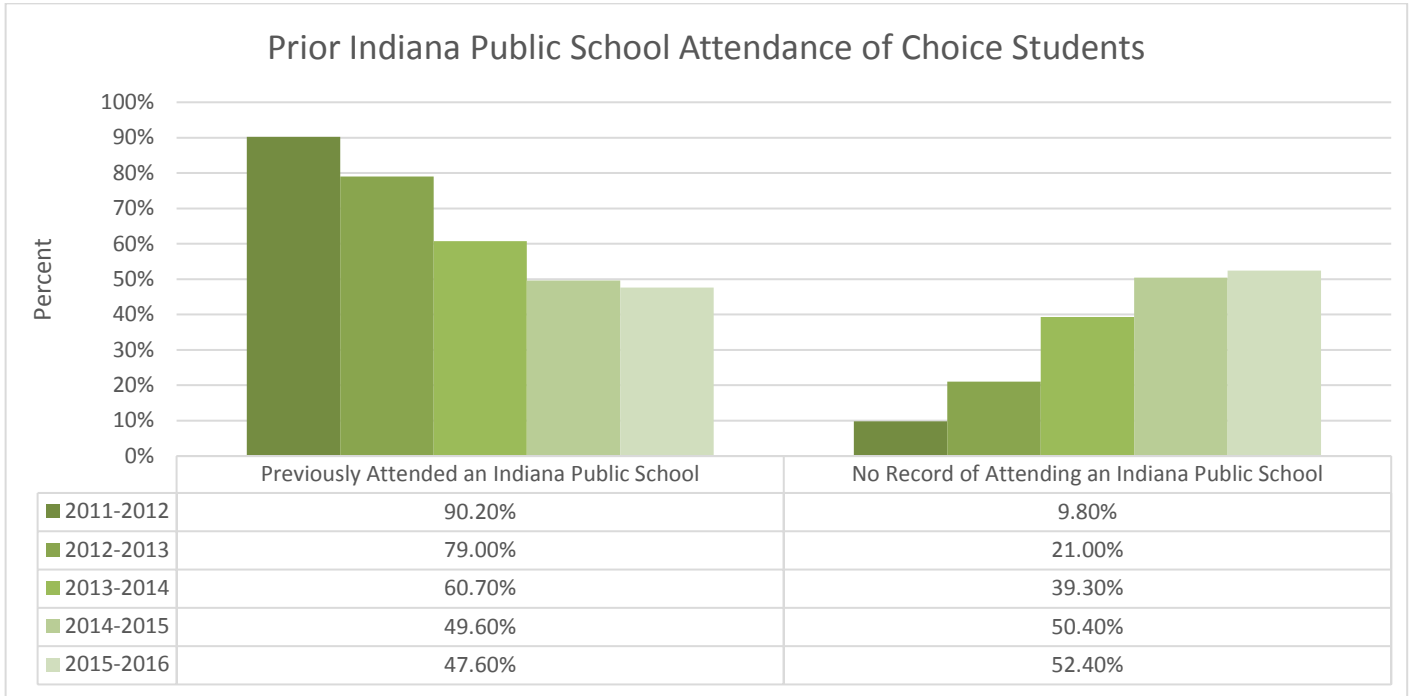

In each subsequent year of the Choice Scholarship Program, the percentage of Choice Students who attended an Indiana Public School at any previous point in their educational history has decreased. For the 2015-2016 school year, less than 48 percent of students participating in the Choice Scholarship Program have a record of previously attending an Indiana Public School.



NEW CHOICE STUDENT PARTICIPATION BY PATHWAY AND PRIOR INDIANA PUBLIC SCHOOL ATTENDANCE 2015-2016

Of the 32,686 students participating in the 2015-2016 Choice Scholarship Program, 22,790 received a Choice Scholarship and applied through either the Continuing or Previous Choice Pathways. For the other 9,896 students in the program, 3,417 applied through the Two-Semesters in Public School Pathway. The remaining 6,479 students applied under the F School, Previous SGO, Sibling, and Special Education Pathways. None of the F School, Previous SGO, Sibling, or Special Education Pathways require prior attendance in an Indiana Public School. Table 13 illustrates whether each student who applied under one of these pathways had attended an Indiana public school at any previous point in his/her educational history.

Special Education

During the 2013 session of the Indiana General Assembly, legislation was passed adding the Special Education Pathway and allowing non-public schools to be the designated Special Education Service Provider for eligible Choice Scholarship Students. Choice Schools that are selected as the Special Education Service Provider and that agree to provide special education services to eligible Choice Scholarship Students may receive state special education funding for eligible Choice Students.

Prior to this legislation, non-public schools were not eligible to receive state special education funding for any eligible special education student. At the time of application, the parent/guardian of a Choice Student requiring special education or related services must designate the Choice School or the public school as the special education service provider. If the Choice School is selected as the special education service provider, the school is eligible to receive state special education funding for any eligible special education Choice Student.

Table 14 details the Special Education Service Provider selection of eligible Choice Scholarship Students. For the 2015-2016 school year, 3,204 Choice Scholarship Students were eligible for special education and related services as reported on their Choice Scholarship application. Of these students, 593, or 18.51%, selected their Choice School as the Special Education Service Provider while the other 2,611, or 81.49%, selected the public school corporation.

Seventy-two Choice Schools were selected as the Special Education Service Provider for at least one eligible Choice Scholarship Student. As provided in Table 15, these Choice Schools received a combined special education payment for eligible Choice Students of \$1,336,342.04. In cases where a student who designated the Choice School as the service provider exited the Choice School prior to the end of the school year, a prorated refund of the special education funding was returned to the Department.

PARTICIPANT RETENTION DURING THE SCHOOL YEAR

Participating Choice Schools are required to report a Choice Scholarship Student who withdraws from the Choice School to the Department of Education within five days of the student's exit date. Table 16 provides the count, and percentage, of students who exited a Choice School prior to the last day of school.

Over 90% of Choice Scholarship Students completed a full school year at the Choice School in each of the first four years of the program.

PARTICIPANT RETENTION BETWEEN SCHOOL YEARS

Table 17 illustrates student retention in the Choice Scholarship Program between school years. Of the 32,686 Choice Scholarship Students who are participating in 2015-2016 program, 23,505 of those students participated in the 2014-2015 school year. For the 2015-2016 school year, 22,790 students applied under the Continuing or Previous Choice Scholarship Pathways. The other 715 students were eligible to apply under either the Continuing or Previous Choice Pathways, but applied under a different pathway.

AWARDS

CALCULATION OF AWARD AMOUNT

For the 2015-2016 school year, the value of the Choice Scholarship is the lesser of two amounts:

- 1) Tuition and fees charged to the student at the eligible Choice School;
- 2) An amount based off the per-student state funding for the student's public school corporation of residence, determined as follows:
 - **90%** of the funding formula amount if household income is up to 100% of Reduced Lunch eligibility.
 - **50%** of formula amount if household income is up to 150% of Reduced Lunch.
 - **50%** of formula amount if household income is up to 200% of Reduced Lunch eligibility if the student received a Choice Scholarship for the 2014-2015 school year **OR** if the student has a disability that requires special education.

The 90% and 50% award amount calculations, which use the per-student state funding amount by school corporation of residence for the 2015-2016 school year, are posted at: <https://www.in.gov/doe/students/indiana-choice-scholarship-program/>.

Beginning in the 2015-2016 school year, the maximum award amount of \$4,800 for grades 1-8 was removed. Thus, the maximum award amount is the lesser of the tuition and fees charged to the student at the eligible Choice School or the 50% or 90% award amounts based on the funding formula.

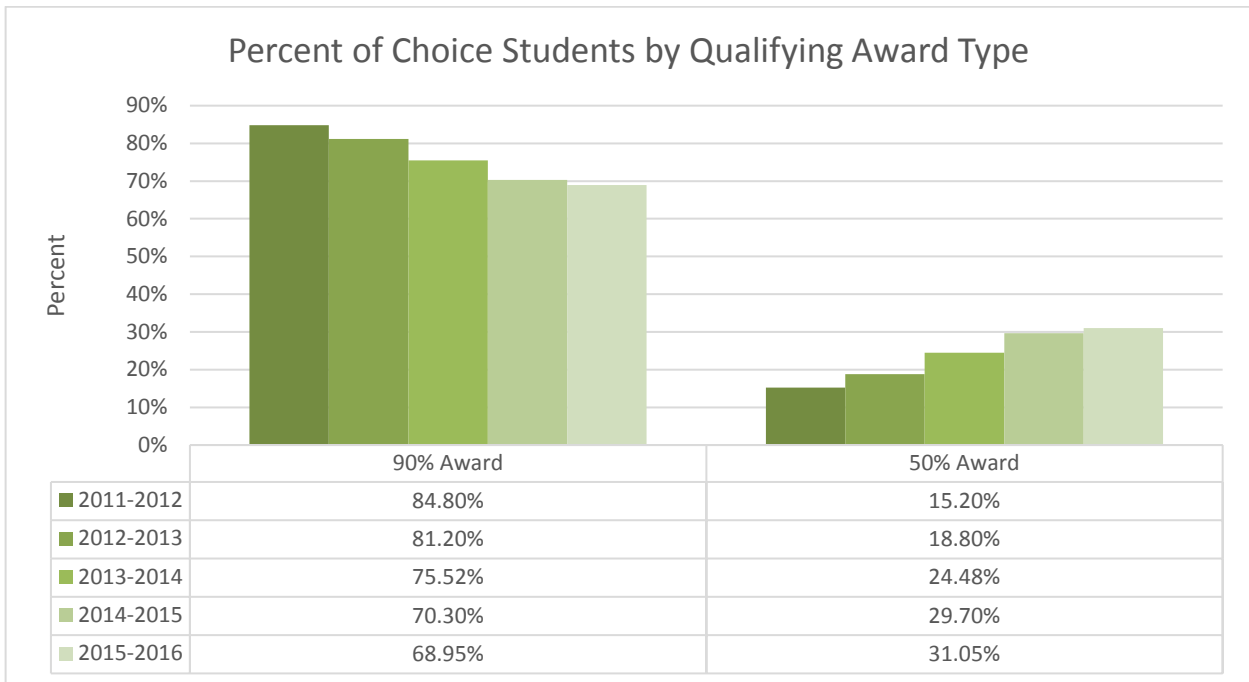

For the 2015-2016 school year, 68.95% of participating students met the income criteria for the Federal Free or Reduced Lunch Program and qualified for a 90% award scholarship. This is a decrease from the 2014-2015 school year when 70.30% of students qualified for the 90% award. In 2015-2016, 31.05% percent of students met the income guidelines to qualify for a 50% scholarship award compared to 29.70% in 2014-2015.

As illustrated in the graph, in each subsequent year of the Choice Scholarship Program, the percentage of students receiving the 90% award has decreased and the percentage of students receiving the 50% award has increased.



Beginning with the 2013-2014 school year, to qualify for the 50% Choice award, students eligible under the Continuing Choice Scholarship Student or Special Education Pathways are subject to an income cut off of 200% of the amount to qualify for the Federal Free or Reduced Lunch Program. Students qualifying under all other pathways are subject to an income cut off of 150% of the amount to qualify for the Federal Free or Reduced Lunch Program.

Tables 19a and 19b provide the breakdown by income category of the 50% award recipients under the Continuing Choice Student and Special Education Pathways. Of the 7,714 students who qualified for a 50% Choice Scholarship under the Continuing Choice Student or Special Education Pathways in 2015-2016, 2,124 or 27.53%, of these students qualified under the expanded income bracket of 150% to 200% of the amount to qualify for the Federal Free or Reduced Lunch Program. In addition, 72.47% of these students met the original income cut off of 150% of the amount to qualify for the Federal Free or Reduced Lunch Program.

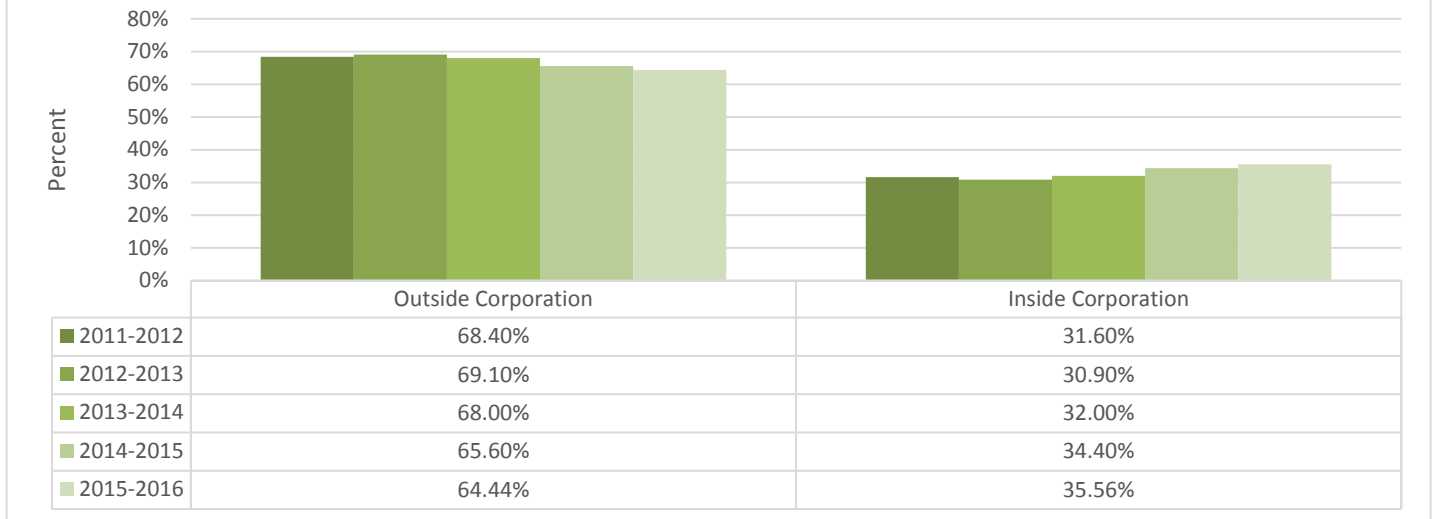

CHOICE SCHOLARSHIP PAYMENTS

Choice Scholarship award payments are made to the Choice School on the student's behalf once each semester. The student (if 18 years of age or older) or the student's parent or guardian signs an Endorsement Form authorizing the Department of Education to disburse the scholarship funds directly to the school on behalf of the student.

IC 20-51-4-6 specifies, "(a) If an eligible Choice Scholarship Student enrolls in an eligible school for less than an entire school year, the Choice Scholarship provided under this chapter for that school year shall be reduced on a prorated basis to reflect the shorter school term."

The payment and prorated refund amounts for the first four years of the Choice Scholarship Program are detailed in Table 26.

CHOICE SPECIAL DISTRIBUTION

Under a non-code provision passed as part of the 2013 budget bill, the Department of Education made a special distribution in 2012 and 2013 to each school corporation and charter school, excluding virtual charter schools, resulting from the Choice School Program implemented under Indiana Code 20-51-4. The calculation for 2014 and 2015 did not result in a distribution.

For 2016, the Department continued to use the five-step formula outlined below.

STEP ONE: Determine the total amount distributed in the year to all individuals for a scholarship under the Choice Scholarship Program described in IC 20-51-4.

STEP TWO: Determine the total amount of state tuition support that all school corporations and charter schools (other than virtual charter schools) would have received in the year if those individuals who received a scholarship and who were enrolled in a public school during the preceding two (2) semesters

before first receiving the scholarship had instead remained enrolled in public schools and had not enrolled in private schools.

STEP THREE: Determine the result of:
 (A) the STEP TWO result; minus
 (B) the STEP ONE amount.

STEP FOUR: Determine each school corporation's percentage and each charter school's (other than a virtual charter school) percentage of the total state tuition support that will be distributed to school corporations and charter schools (other than virtual charter schools).

STEP FIVE: Multiply the result determined in STEP THREE by the school corporation's percentage or the charter school's (other than a virtual charter school) percentage determined under STEP FOUR.

The amount of the Choice Special Distribution, as calculated by the five step formula above, for first four years of the Choice Scholarship Program is provided in Table 28.
