## Indiana School Scholarship Tax Credit Program Annual SGO Program Report

December 22, 2021

Indiana Code 20-51-3-6 requires Scholarship Granting Organizations (SGOs) to provide the Indiana Department of Education with annual and financial report information. As part of the annual report, SGOs are required to provide the Department with the following information:

- 1. The total number and total dollar amount of contributions received during the previous school year, and
- 2. The total number and total dollar amount of school scholarships awarded during the previous school year.

The contribution and school scholarship information provided by each participating SGO in their annual report is provided below for the 2018-2019 through 2020-2021 school years.
