Indiana Code 20-51-3-6 requires Scholarship Granting Organizations (SGOs) to provide the Indiana Department of Education (IDOE) with annual and financial report information. As part of the annual report, SGOs are required to provide the following information to IDOE:

- 1. The total number and total dollar amount of contributions received during the previous school year, and
- 2. The total number and total dollar amount of school scholarships awarded during the previous school year.
