INDIANA SCHOOL CHOICE SCHOLARSHIP PROGRAM HISTORY

This latest iteration of the Choice Scholarship Program Annual Report incorporates data from both the 2023-2024 and 2024-2025 school years, building upon the initial release in 2014. Since certain data will not be finalized until June 2025, some 2024-2025 information will be reflected in the 2025-2026 report. Prior Choice Scholarship Program Annual Reports can be found on the Indiana Department of Education's (IDOE's) [Indiana Choice Scholarship Program webpage](#).

Part of this report includes an overview of Indiana's current Choice Scholarship Program, which was passed as part of House Enrolled Act (HEA) 1003 (2011) (i.e., Public Law 92 [2011]). The Choice Scholarship Program provides Choice Scholarships to students who meet specific statutory criteria. These scholarships are used to offset and assist with the cost of tuition and fees at participating Choice schools for eligible families.

The legal foundation for Indiana's Choice Scholarship Program can be found in Indiana Code (IC) 20-51 and 512 Indiana Administrative Code (IAC) 4, or on IDOE's [Indiana Choice Scholarship Program webpage](#).

ELIGIBILITY

As stated above, students must satisfy statutory eligibility requirements to participate in Indiana's Choice Scholarship Program.

STUDENT ELIGIBILITY CRITERIA

All students must satisfy the following two requirements:

1. Have legal settlement in Indiana; and
2. Be at least five years of age and less than 22 years of age on October 1 of the school year.

After meeting the above criteria, students must satisfy the requirement of income eligibility criteria, which is 400% of the household income, to qualify for the Federal Free or Reduced Lunch Program.

INCOME ELIGIBILITY CRITERIA

The income criteria to participate in the Choice Scholarship Program for the 2024-2025 school year, shown in Table 1 on the next page, are linked to the Federal Free or Reduced Price Lunch Program income guidelines.

The 90% award amounts are percentages of the tuition support amounts that the respective student's public school corporation of legal settlement would receive if the student enrolled in a public school in that corporation.

PARTICIPATION

STUDENT AND SCHOOL PARTICIPATION

Beginning with the 2019-2020 school year, a second Choice student application period was put in place. The original application, period one, is open annually from March 1 to September 1. The second application, period two, is open from November 1 to January 15. For purposes of the Choice Scholarship Program Annual Report, a school is only counted as participating if they have one or more students receive payment, and students are only counted as participating if they receive a payment during the 2024-2025 school year.

The 2024-2025 school year saw growth in the total number of participating students while also having a marginal decrease in the number of period two participating students. The 2023-2024 Choice Scholarship Program had 68,766 participating students in period one, 1,329 participating students in period two, and 357 participating schools. The 2024-2025 school year saw an increase in participating schools to 373, the most participating schools of any year of the Choice Scholarship Program. There were 74,743 participating students in period one and 1,324 participating students in period two, which increased the total number of participating students for the 2024-2025 school year to 76,067.

The period two application was established, by law, to provide an opportunity for eligible students to transfer to a new Choice school and receive a Choice Scholarship after the September 1 deadline. However, 1,324 students did not participate during period one and were new to participating in the 2024-2025 Choice Scholarship Program. Additionally, 158 participating students from period one participated in period two. Because these students were



counted in the student count for period one, they were excluded from the period two count of 1,324, to avoid a duplicated count. The change in student participation is indicated below.

Table 3 illustrates the participating student applicant types for the 2024-2025 period two participating students. The table details whether a student participated in 2024-2025 period one, withdrew from the school for any reason, and participated for 2024-2025 period two; or if the student did not participate during 2024-2025 period one and participated for 2024-2025 period two and received only a period two Choice Scholarship award for the 2024-2025 school year.

Table 4, below, illustrates students that withdrew during the 2024-2025 school year and participated in both application periods. The table shows students who participated during the first period application, left their original Choice school, and whether they returned to the same Choice school to apply and participate for the second period or enrolled, applied, and participated at a different Choice school for the second period. With 137 students changing schools from period one to period two, this means only 9.24% of period two participants and 0.18% of students are utilizing the period two application as it was intended.

Non-public schools, consisting of Choice and non-Choice schools, accounted for 8.70% of statewide student enrollment for the 2024-2025 school year. This is an increase of 0.47% from the 2023-2024 school year. Choice student enrollment increased by 0.45% over the same time period, which is only reflected by the period one count of 74,743. Overall state enrollment increased except for in traditional public schools, which increased in the number of students but decreased as percentage of the state total enrollment. All other school types saw an increase in enrollment count and percentage.

PARTICIPATION BY GRADE LEVEL

The count of program participants by grade level, as well as the percent each grade level accounted for in terms of program participation each year, are detailed in Table 7. From the 2023-2024 school year to the 2024-2025 school year, no grade level increased or decreased by more than 0.37% as a percentage of participating students in the Choice Scholarship Program. The largest decrease, 0.19%, was found in the sixth grade. The largest increase, 0.37%, was found in the eleventh grade.

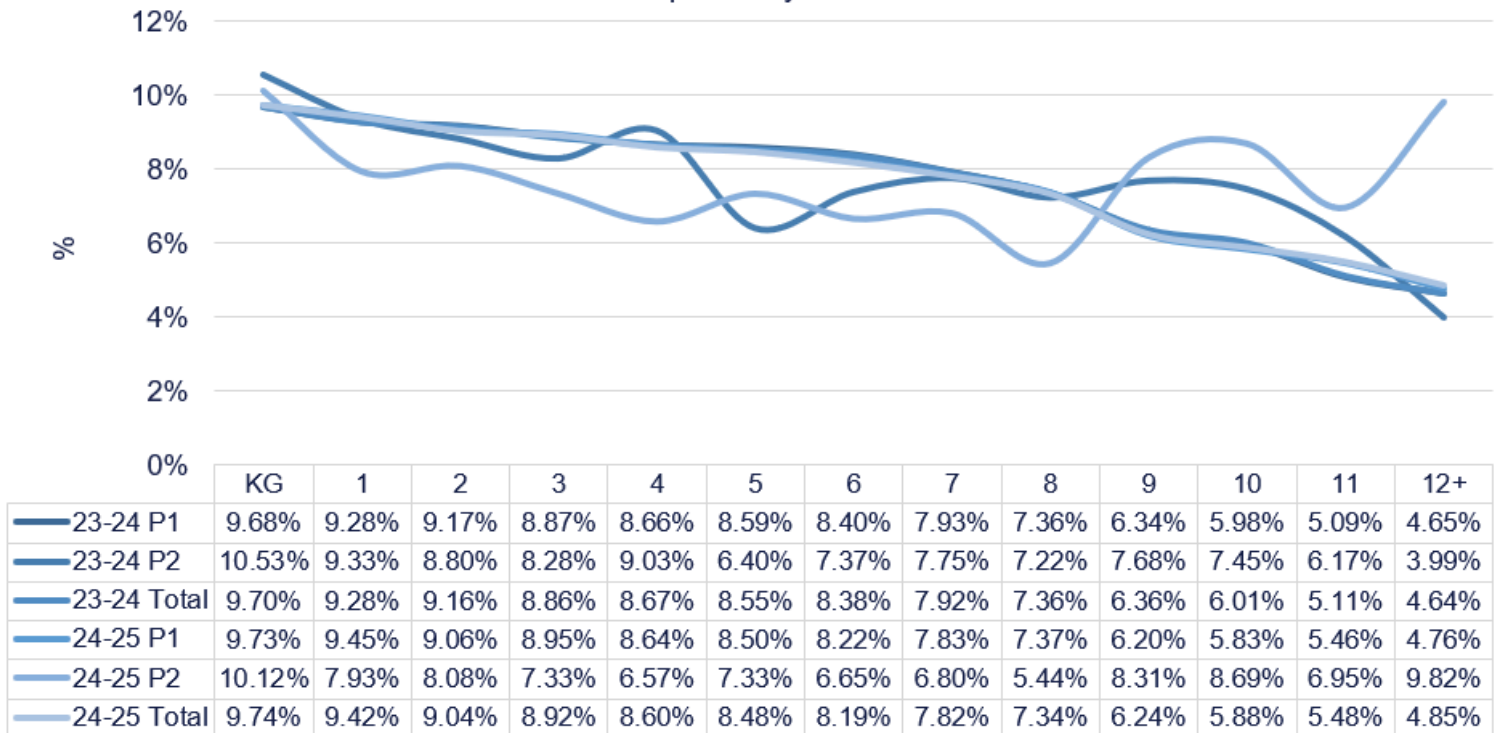
The graph on the following page shows the changes from the 2023-2024 school year to the 2024-2025 school year. The removal of eligibility tracks in the 2023-2024 school year led to a drastic increase in kindergarten participation last year. This increase was reflected in the graph last year but 2024-2025 now reflects a similar distribution to 2023-2024. Period one and total for both 2023-2024 and 2024-2025 are so similar that it is difficult to see separate lines in the graph.

PARTICIPATION BY GENDER

Tables 8a and 8b provide data on the gender of participating Choice Scholarship students. In each year of the program, slightly more female students have participated than male students. The 2024-2025 school year has shown a slight increase in the percentage of female students and a slight decrease in male students. The changes in each year are marginal and female students still make up just over 50% of the participating students in the Choice Scholarship Program. Overall, the percentages for male and female participating students are nearly 50% each. However, period two does show a disproportionate difference from period one and total with 52.11% female and 48.89% male student participation. From the 2023-2024 school year to the 2024-2025 school year, there was a 0.20% increase in female students and 0.20% decrease in male students in total.

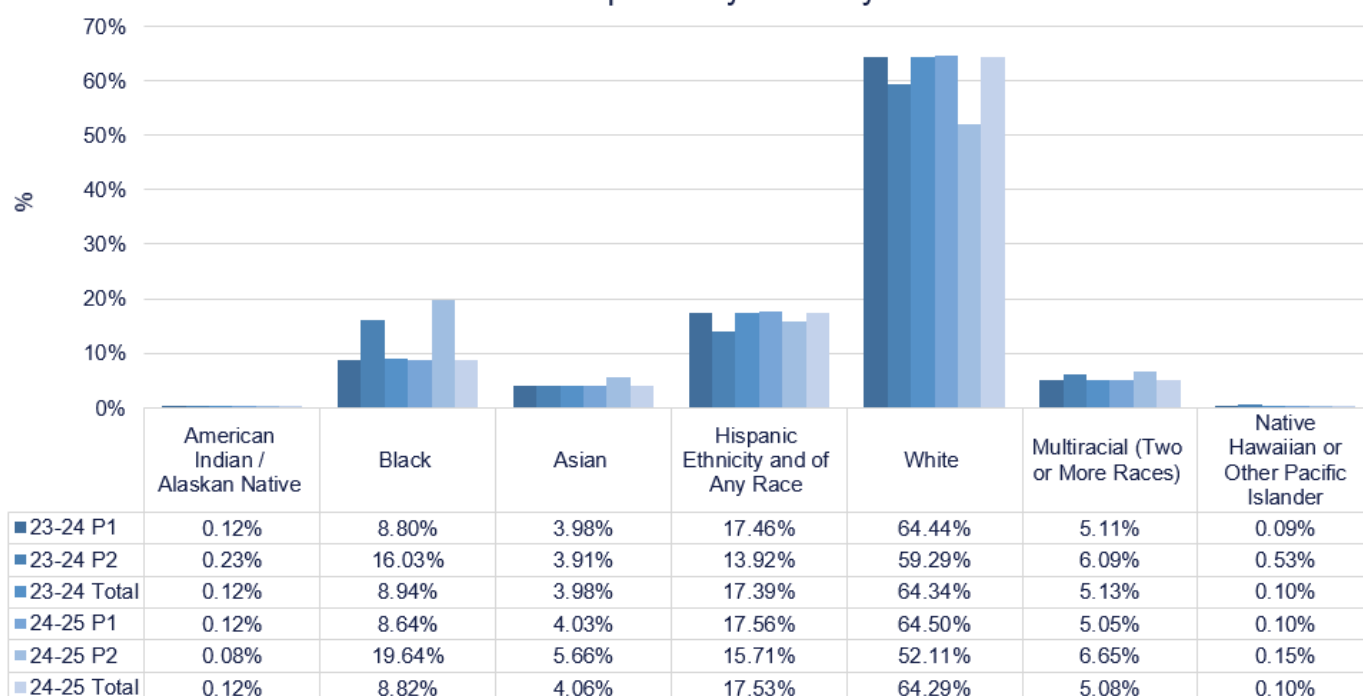

The graph below depicts the percentage of participation by reported ethnicity of Choice Scholarship students. Black ethnicity, White ethnicity, and Multiracial (two or more races) ethnicity were the only ethnicities that saw a decrease from 2023-2024 to 2024-2025 with a decrease of 0.12%, 0.05% and 0.05%, respectively. Hispanic ethnicity and of any race that makes up the second largest group of students saw the largest increase from 2023-2024 to 2024-2025 at 0.14%. All other ethnicities increased by no more than 0.08% each. The graph illustrates how closely the percentages for period one and the total are for both 2023-2024 and 2024-2025. Additionally, the graph illustrates how period two fluctuates from other illustrated periods.

PARTICIPATION BY GEOGRAPHIC AREA

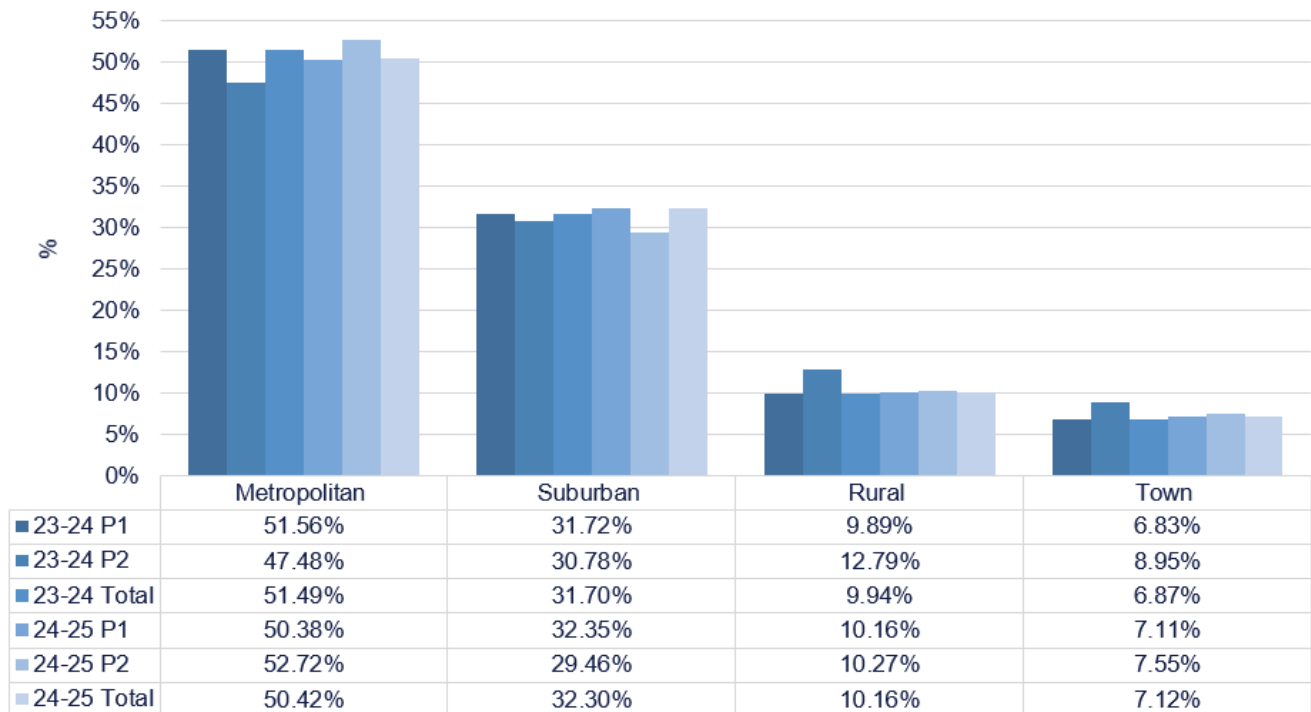
Each public school corporation in Indiana is categorized as one of four geographic types – metropolitan, suburban, rural, or town. The geographic area for each student is determined by the public school corporation where the student lives. As illustrated in Table 10, most students live in a metropolitan area; however, this area saw the only decrease from the 2023-2024 school year to the 2024-2025 school year at 1.07%. Suburban, rural, and town areas experienced an increase from the 2023-2024 school year to the 2024-2025 school year of 0.60%, 0.22%, and 0.25% respectively.

PARTICIPATION BY PRIOR INDIANA PUBLIC SCHOOL ATTENDANCE

Table 11 and the graph found below provide the count and percentage of Choice Scholarship students who previously attended an Indiana public school at any point in their educational history.

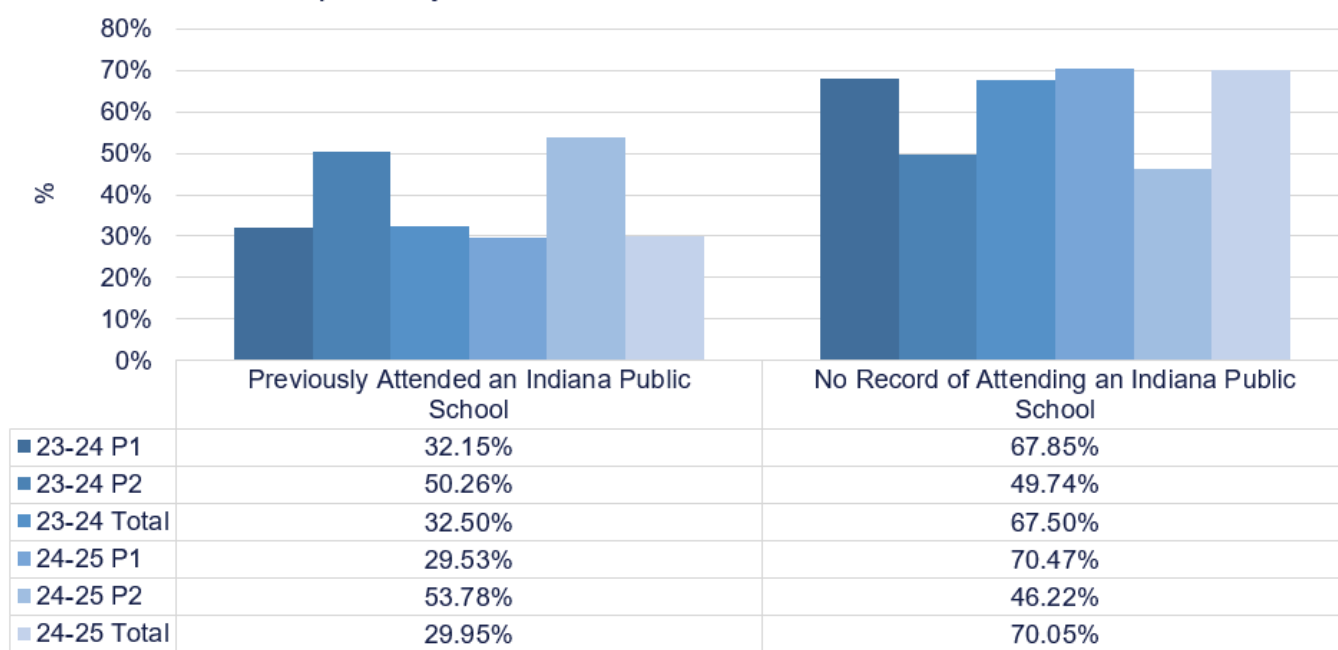

For the 2024-2025 school year, roughly 30% of students participating in the Choice Scholarship Program have a record of previously attending an Indiana public school. The percentage of students with a record of previously attending an Indiana public school was at roughly 33% for the 2023-2024 school year. This decrease is likely due to students who were already enrolled at their Choice school now qualifying without prior attendance at an Indiana public school.

Percentages for period one and the total in 2023-2024 and 2024-2025 are comparable, while the percentages for period two for both years show the opposite of period one and total. The data shows a trend of fewer participating students ever attending an Indiana public school.

SPECIAL EDUCATION

During the 2013 legislative session of the Indiana General Assembly, legislation was passed allowing non-public schools to be the designated special education service provider for eligible Choice Scholarship students. Choice schools that are selected as an eligible student's special education service provider and agree to provide associated services may receive state special education funding to meet these student's needs. Prior to this legislation, non-public schools were not eligible to receive state special education funding for any eligible special education student.

At the time of application, the parent/guardian of a Choice student who qualifies to receive special education services must designate the Choice school or the public school corporation as the special education service provider. If the Choice school is selected, they are eligible to receive state special education funding for the student.

Table 12 and the following graph detail the special education service provider selection of eligible Choice Scholarship students by their respective parent/guardian. For the 2024-2025 school year, 5,553 participating Choice Scholarship students were eligible for special education as reported on their application. Of these students, 964, or 17.36%, selected their Choice school as the special education service provider while the other 4,589, or 82.64%, selected the public school corporation where the Choice school is located if the Choice school is a physical location. For virtual Choice schools, the public school corporation providing services would be the corporation where the student lives.

Compared to the 2023-2024 school year, 0.33% fewer applicable students chose the Choice school as the special education service provider in 2024-2025. Period one and total percentages for 2023-2024 and 2024-2025 were all between about 17% and 18% for Choice schools and between 82% and 83% for the public school corporation. Period two showed much different percentages, coming in around 17% and 25%, for 2023-2024 and 2024-2025, respectively, of students selecting the Choice school as the special education service provider, while 83% and 75%, for 2023-2024 and 2024-2025, respectively, selected the public school corporation.

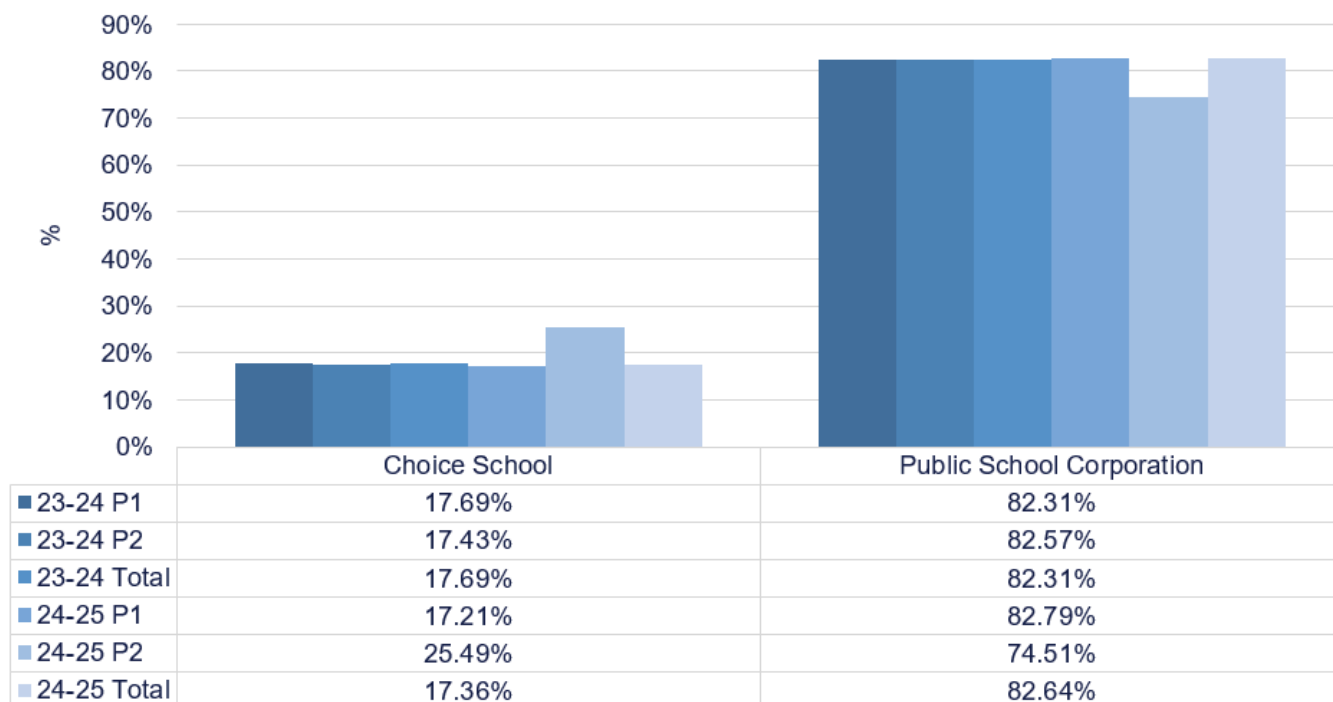

Special Education Service Provider Selection Percentage



For the 2024-2025 school year, 88 Choice schools were selected as the special education service provider for at least one eligible Choice Scholarship student, but only 68 of the schools received a payment for at least one student. The information shown in Table 13 shows the special education payment information for Choice schools for 2023-2024. In 2023-2024, Choice schools received a combined special education payment for eligible Choice students of \$3,143,235.66. In cases where a parent/guardian who selected the Choice school as the service provider, and the student withdrew from the Choice school prior to the end of the school year, a prorated refund of the special education funding was returned to IDOE.

RETENTION

PARTICIPANT RETENTION DURING THE SCHOOL YEAR

Participating Choice schools are required to report a Choice Scholarship student who withdraws from the Choice school to IDOE within five days of the student's exit date. Table 14 provides the count and percentage of participating students who exited a Choice school prior to the last day of school.

PARTICIPANT RETENTION BETWEEN SCHOOL YEARS

Table 15 below illustrates participating student retention in the Choice Scholarship Program between school years. Of the 76,067 Choice Scholarship students who participated in the 2024-2025 Choice Scholarship Program, 58,433 of those students participated in the 2023-2024 school year. The 76.82% retention rate from 2023-2024 to 2024-2025 shows a roughly 13% increase from 2022-2023 to 2023-2024.

AWARDS

CALCULATION OF AWARD AMOUNT

Currently, the value of the Choice Scholarship is the lesser of two amounts:

- 1) Tuition and fees charged to the student at the eligible Choice school; or
- 2) An amount based off the per-student State funding for the student's public school corporation of residence, determined as follows:
 - 90% of the funding formula amount if household income is up to 400% of Federal Free or Reduced Price Lunch eligibility.

The 90% amount calculation, which uses the per-student State funding amount by public school corporation of residence for the 2024-2025 school year, was posted on IDOE's [Indiana Choice Scholarship Program webpage](#). Currently, the 2025-2026 estimated award amounts are found on the Choice website.

AWARDS BY TYPE

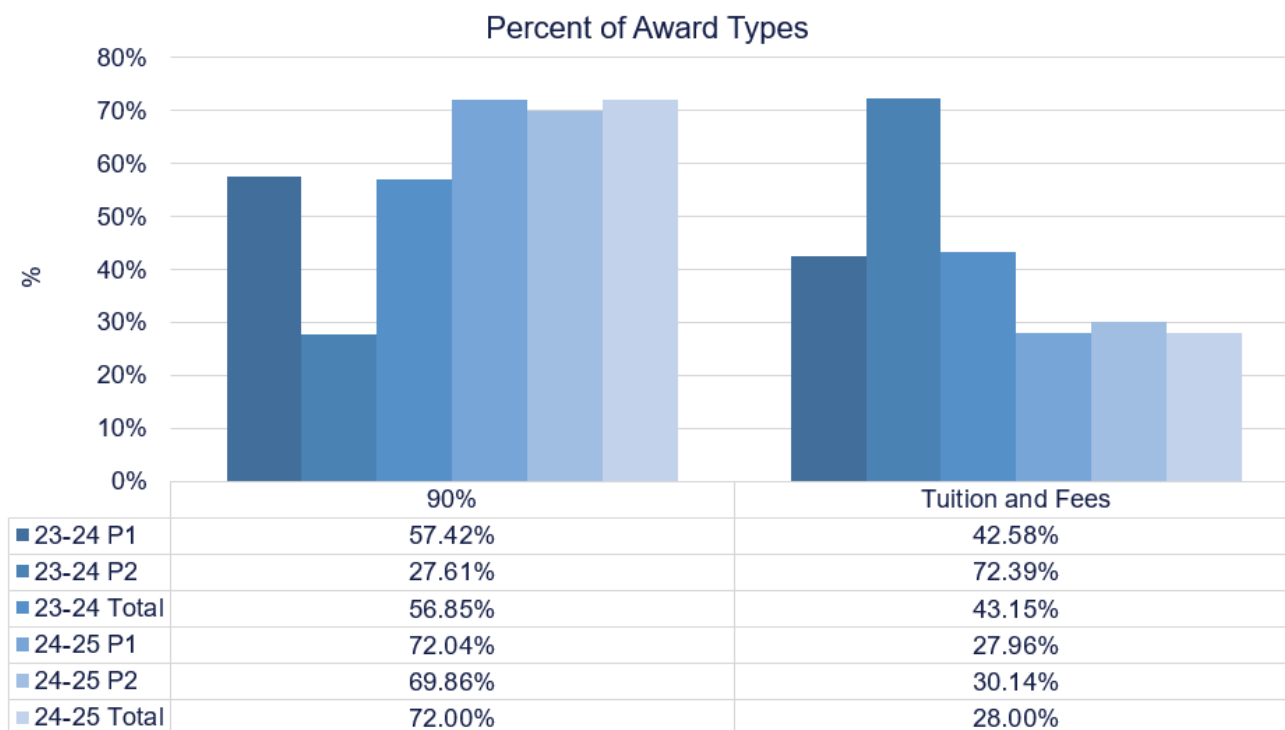
As previously stated, the award amount for a student is the lesser of their respective Choice school's tuition and fees amount entered on the applying student's application or the 90% tuition support amount for the public school



corporation of legal settlement entered on the applying student's application. Table 16 below shows the number of students that had tuition and fees as the lesser amount and the number of students that had the 90% amount as the lesser amount.

The graph below shows that the 90% award type increased by 15.15% and the tuition and fees award type decreased by 15.15% from the 2023-2024 school year to the 2024-2025 school year. The graph also shows that the distribution of award types for period two now more closely resembles the distribution of award types in period one and the total. This increase in 90% award amounts would indicate that more Choice Scholarship eligible families are now required to pay some of their tuition and fees since the Choice Scholarship award is less than the tuition and fees amount at their Choice school.



In addition to household income and household size, the Choice Scholarship Program utilizes the Choice Scholarship Eligibility System (CSES) as verification that Choice students satisfy the income eligibility aspect of the application process. Starting in the 2024-2025 school year, foster child status is no longer utilized as it is captured in the CSES. The CSES is not required by law but has been implemented by IDOE to assist schools and families. The CSES is a database compiled of students who qualify for certain benefits from other State administered financial



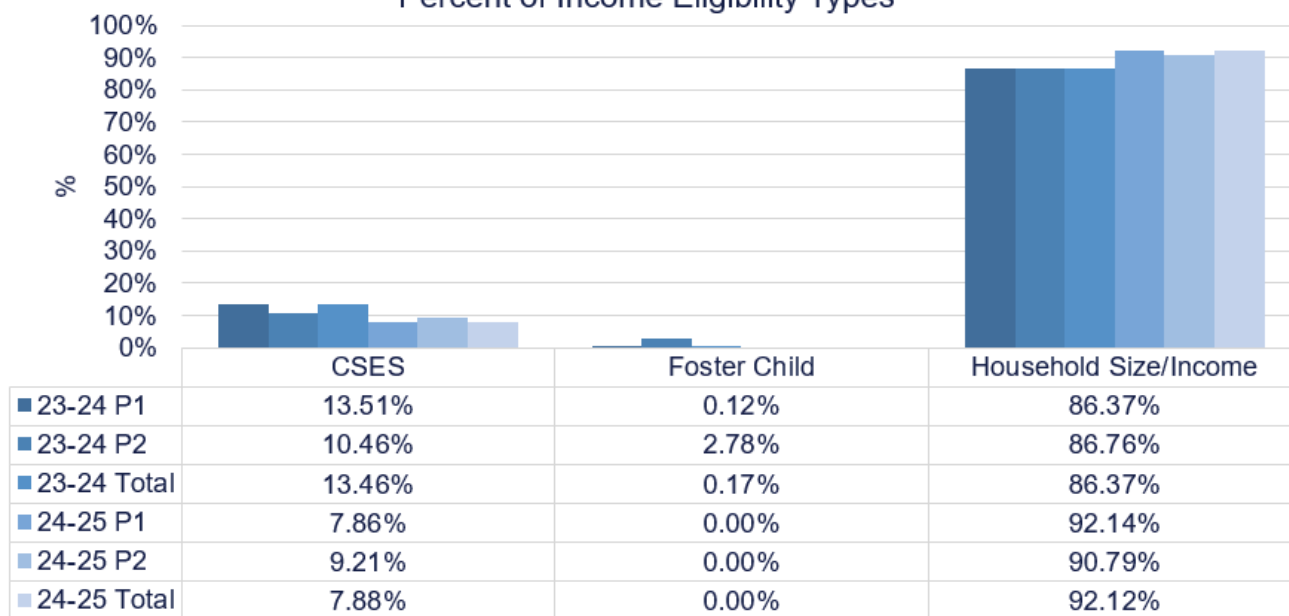
assistance programs. Table 17 below outlines the breakdown of students by the avenue in which they satisfied the income criteria.

The graph below illustrates that the majority of students utilize household size and income to satisfy income eligibility with 92.12% of students.

Percent of Income Eligibility Types



Tables 18 and 19 outline the reported household sizes and incomes for the 92.12% of students who applied using household income and size for their income eligibility. Of those students, 90.75% live in a household with six or less people, and 78.29% of these students live in a household with an annual household income of \$150,000 or less. The average household size and income for 2024-2025 total are 4.65 and \$102,842.66, respectively. This shows a marginal decrease in the average household size of 0.01 from 2023-2024 to 2024-2025 and a slight increase in household income of \$3,721.58. Although the income limit is 400%, a household size of 4.65 with an income of \$102,842.66 is 178.18% of the Free or Reduced Price Lunch Program for a household size of 4 and 151.97% for a household size of 5. These percentages are a slight decrease from 2023-2024 to 2024-2025 and that is likely due to the income levels growing by a larger amount than the average household income amount of participating Choice Scholarship students.

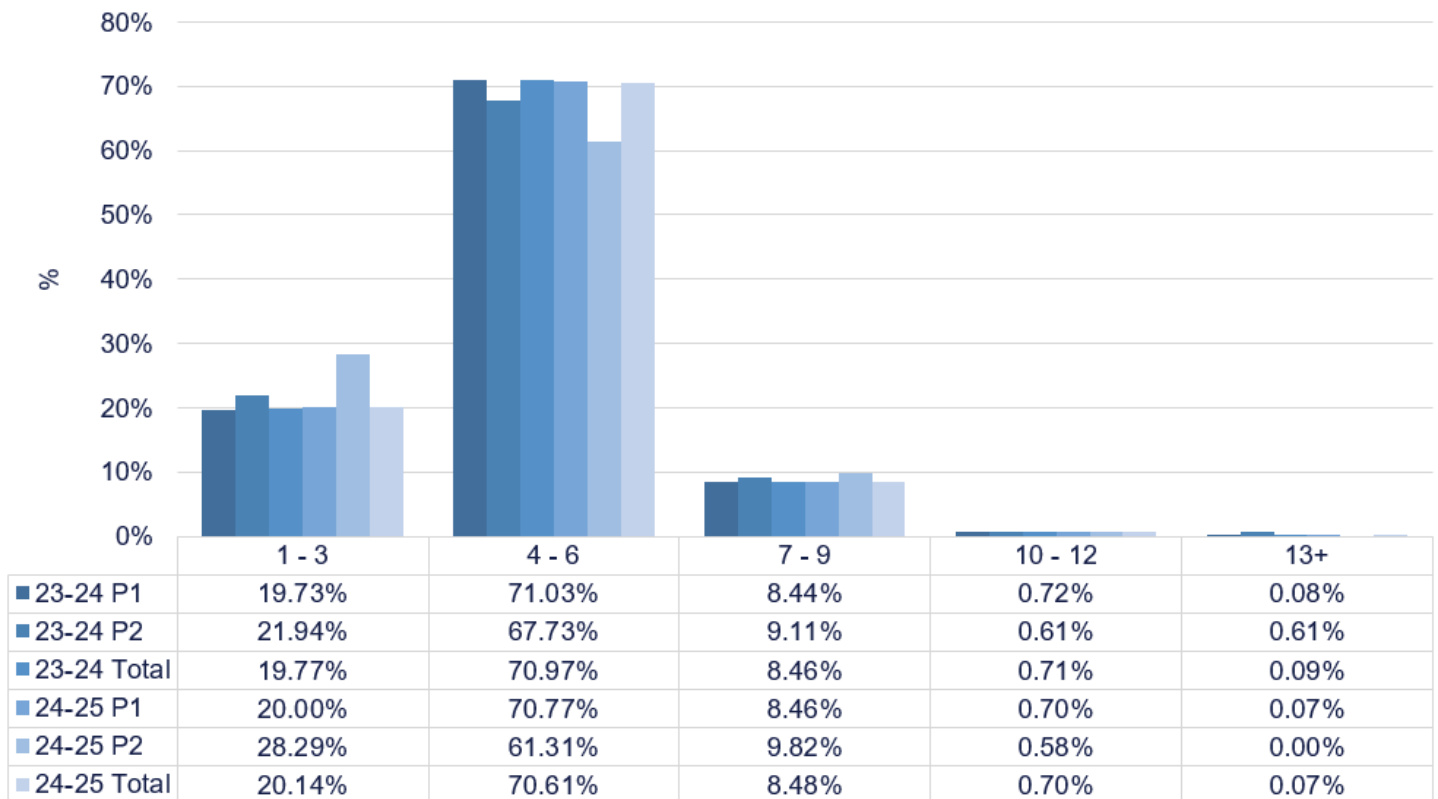

As shown in the graph below, the only household size types to increase from 2023-2024 to 2024-2025 were 1-3 and 7-9 at 0.37% and 0.02%, respectively. The largest decrease from 2023-2024 to 2024-2025 came in household size type of 4-6 with roughly 0.36%.

As shown in Table 19 and the graph on the next page, only household income types \$150,001-\$200,000 and \$200,001+ increased for 2024-2025. The largest increase from 2023-2024 to 2024-2025 came in household income of \$200,000+ at roughly 1.65%. The largest decrease from 2023-2024 to 2024-2025 came in household income of \$50,001-\$100,000 at roughly 1.65%.

Percent by Household Income Types

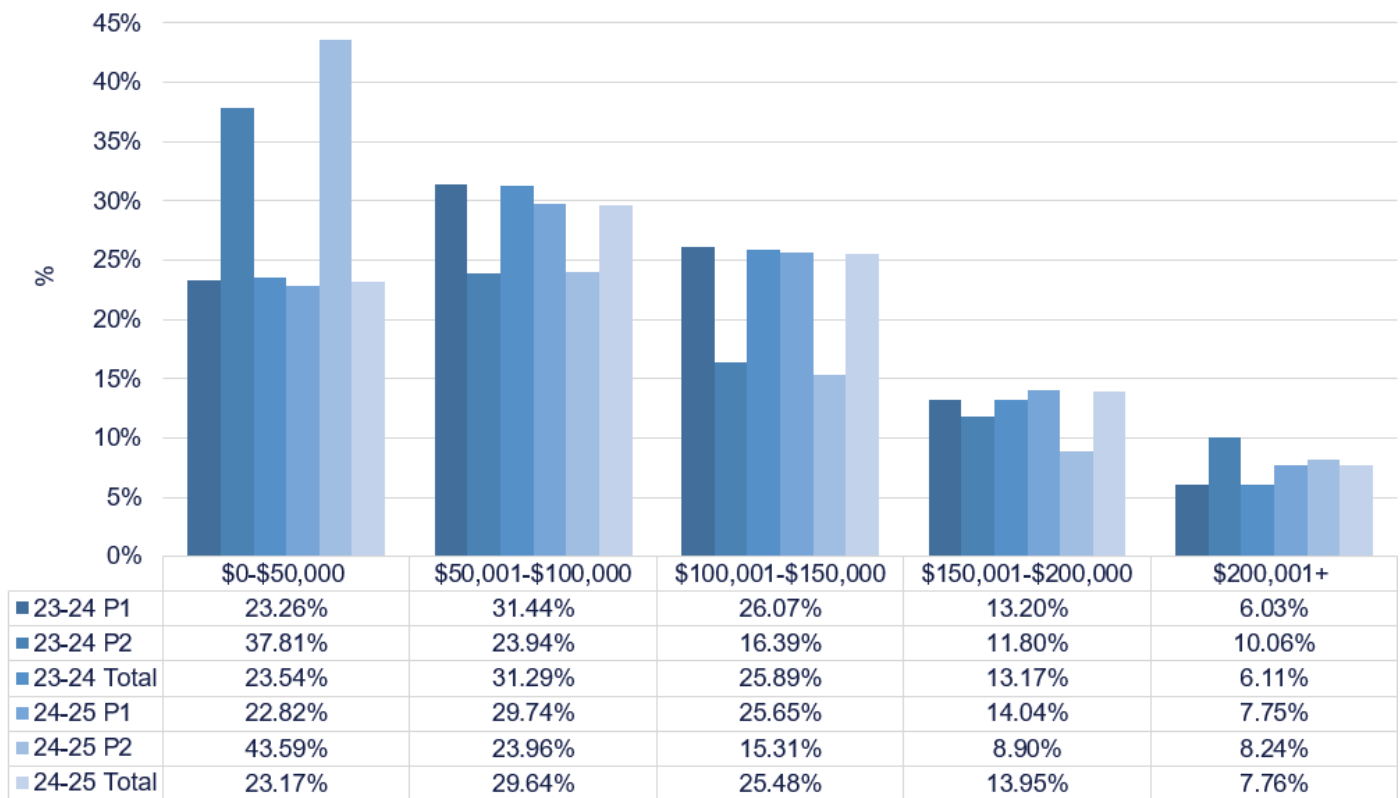
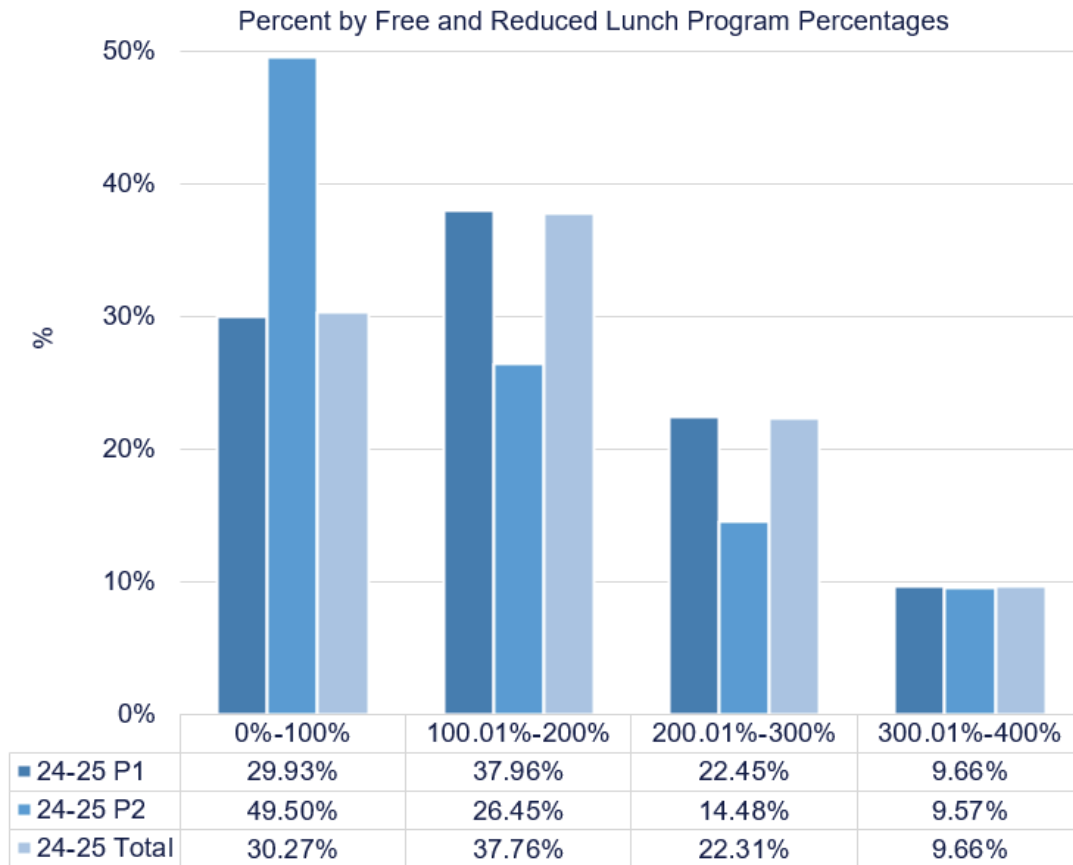

AWARD AMOUNT BY GRADE LEVEL

Table 21 details the total award amount of Choice Scholarship students by grade level. In correlation with Table 7, roughly the same distribution of total award amounts by grade can be seen in total participation by grade. The amounts shown are the maximum that would be paid if every student remained enrolled for the full school year and did not receive a prorated award amount or have a refund owed; it is not the amount that has been paid. Table 21 illustrates the elementary school grade levels as having the most in count and amount. Period two award amounts are calculated to half the award amount of period one award amounts due to the Choice Scholarship only being used for half of the school year.

AWARDS BY PUBLIC SCHOOL CORPORATION OF LEGAL SETTLEMENT

Table 22 provides the count of public school corporations where Choice students had legal settlement in the 2023-2024 and 2024-2025 school years. The Choice student count by public school corporation of legal settlement is provided in Appendix A. Please note that students may not have attended a public school in their public school corporation of legal settlement prior to participating in the Choice Scholarship Program. Overall, the 2024-2025 total saw an increase of eight public school corporations from 2023-2024, or 2.90%.

Choice Scholarship students may apply for, and use, the award at any participating Choice school. Table 23 and the graph on the next page show the count and percentage of Choice Scholarship students who used their award to attend a Choice school located inside or outside the boundaries of the student's public school corporation of legal settlement. For the 2024-2025 school year, 56.00% of students attend a Choice school within the boundaries of their

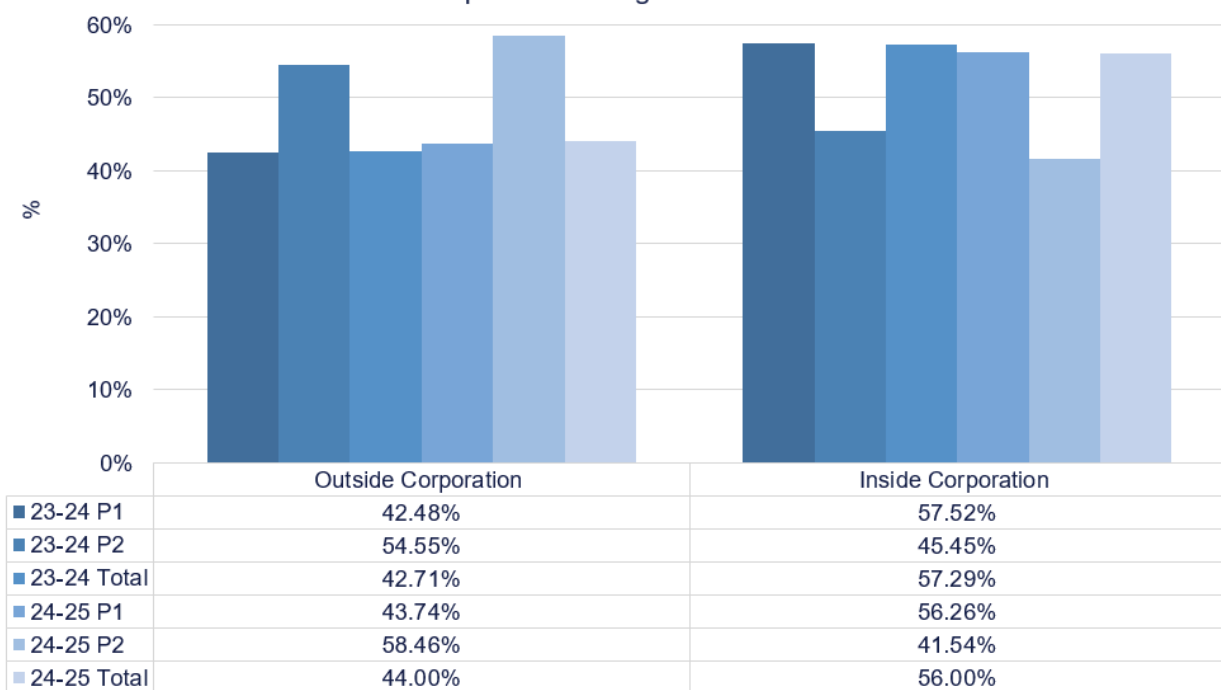

This is not the amount that is paid, but the total of all award amounts. The amount paid for 2023-2024 can be found in Table 27 which is different from the amount in Table 24. A complete listing of the total eligible award amount by Choice school is provided in Appendix C. The amounts shown are the maximum that would be paid if every student remained enrolled for the full school year and did not receive a prorated award amount or have a refund owed. Additionally, period two award amounts are calculated to half the award amount of period one award amounts due to the Choice Scholarship only being used for half of the school year.

Table 25 depicts the different amounts of tuition and fees charged to participating students. Roughly 80% of participating Choice students have a tuition and fee amount of \$5,001 to \$10,000. This is about a 1% increase from 2023-2024 to 2024-2025. All tuition and fee types besides \$0-\$5,000 saw a percentage increase from 2023-2024 to 2024-2025 with \$0-\$5,000 seeing a decrease of about 4.41%. This would indicate that Choice schools have increased their tuition and fees for 2024-2025.

Table 26 depicts the different payment scenarios for the 76,067 students who participated in the 2024-2025 Choice Scholarship Program. As also stated in Table 21, if all Choice students remained at their Choice school for the full year, the total amount that would be paid in Choice awards would be \$497,195,861.37. Based on the reported tuition and fees for those same students at their respective Choice school, the full tuition and fees for all participating Choice students would total \$631,184,966.65 for the 2024-2025 school year. Since 21,300 students received an award amount equal to their reported tuition and fees amount, that leaves \$133,989,105.28 in tuition and fees to be paid by the families of the 54,767 students who did not receive their full tuition and fees as their award amount, averaging \$2,446.53 due to Choice schools per student. Additionally, if the same 76,067 Choice students were to attend their public school corporation of legal settlement for the 2024-2025 school year, the amount that would be paid in public tuition support would total \$567,794,963.30. The first of three caveats made in Table 26 are that \$497,195,861.37 would be paid due to no students withdrawing early. Second, \$631,184,966.65 is the full tuition that Choice schools would charge students in 2024-2025 for period one and half the tuition for period two. The third caveat is the amount of \$567,794,963.30 is if all Choice students were not enrolled at a Choice school, they would enroll at their respective public school corporation even though data indicates that a majority of Choice students have never attended a public school.

CHOICE SCHOLARSHIP PAYMENTS

Choice Scholarship award payments are made to the Choice school on the student's behalf at least once each semester. The student (if 18 years of age or older) or the student's parent or guardian signs an Endorsement Form authorizing IDOE to disburse the Choice Scholarship funds directly to the participating Choice school on behalf of the Choice student.

Indiana Code (IC) 20-51-4-6 specifies, *(a) If an eligible Choice Scholarship student enrolls in an eligible school for less than an entire school year, the Choice Scholarship provided under this chapter for that school year shall be reduced on a prorated basis to reflect the shorter school term.*

The payment and prorated refund amounts for the 2023-2024 Choice Scholarship Program are detailed in Table 27. The information for the 2024-2025 school year will not be available until the end of the 2024-2025 school year and the data will not be published until the 2025-2026 version of the Choice Scholarship Program Annual Report.

2024-2025 CHOICE STUDENT SUMMARY

The following summary of the "average" Choice student is based on data found within the Choice Scholarship Report. "Average" refers to where a majority of Choice students are found within each data set.

The "average" Choice student is a female student in an elementary grade level (kindergarten through fifth grade) of white ethnicity, from a metropolitan area, and a household with a size of 4.65 people and income of \$102,842.66 which is under 200% of the Federal Free and Reduced Lunch Program guidelines. Due to higher tuition and fees, the "average" Choice student has an award equal to 90 percent of the tuition support amount per student at their public school corporation of legal settlement. The average award amount is \$6,536.29 and the average tuition and fees amount is \$8,368.64.

Additionally, the "average" Choice Scholarship student applies during the period one application, participated in the 2023-2024 Choice Scholarship Program, utilizes household size and income for income eligibility, has no record of attending an Indiana public school, and attends a Choice school within the boundaries of their corporation of legal settlement.
