



Education Scholarship Program Estimated Award Amounts 2026-2027 School Year

Indiana is committed to expanding access to quality educational opportunities to all Indiana students. The Education Scholarship Account (ESA) Program provides tax-funded scholarship dollars to K-12 Indiana students with disabilities (and their siblings). ESA students receive 90% of the per-student state funding based on the student's school corporation of legal settlement. Students who require special education services receive 100% of special education funding that would have gone to the public or charter school, in accordance with their qualifying service plan. The ESA award amounts by school corporation are shown in the table below.
