Budget Code Guide

IDOE reviews submitted grant applications and budgets to ensure proposed expenditures are reasonable, allocable (able to proportionally charge to a grant), and necessary (RAN) in order to carry out the stated goals and objectives. Any proposed expenditure must meet all three to be considered. The below graphic contains guiding questions that IDOE utilizes to ensure all expenditures meet the RAN test. Grantees may wish to utilize this information to prepare budgets and grant submissions.
