The transition to PowerSchool Special Programs as the statewide IEP system is beginning. Training materials were released on April 1. Current Indiana IEP system users should receive an email notification with directions for accessing the online and on-demand trainings via

There are two sets of training. The first will be for district-wide administrators. The second is for school users, which includes building administrators who currently use the system. Users have been assigned to a group based on their LINK accounts and current Indiana IEP roles. Live training begins in May for district-wide administrators and in August for school users. Note again that on-demand training
